

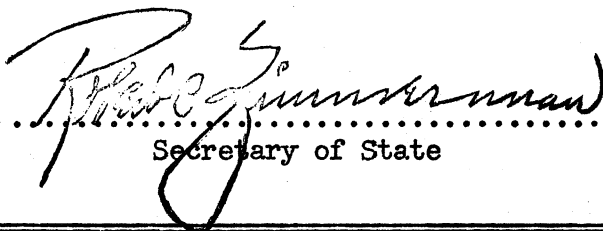

SECRETARY OF STATE

An Ordinance Detaching Lands from the City of Plymouth
and Attaching the same to the Town of Plymouth.

THE MAYOR AND COMMON COUNCIL OF THE CITY OF PLYMOUTH DO
HEREBY ORDAIN AS FOLLOWS:

SECTION 1: The following described lands now situated in the
City of Plymouth, Sheboygan County, Wisconsin, are hereby
detached therefrom, and attached to the Town of Plymouth,
Sheboygan County, Wisconsin:

That part of the Southwest Quarter of the
Northeast Quarter (SW $\frac{1}{4}$ NE $\frac{1}{4}$) of Section 27,
Township 15 North, Range 21 East, lying
South and West of the Southerly right-of-
way line of the Chicago and Northwestern
Railway Co.

SECTION 2: This ordinance shall be in full force and affect
from and after it's passage and publication.

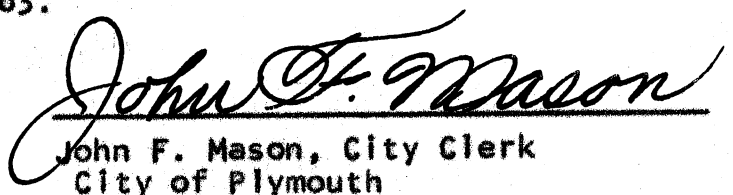

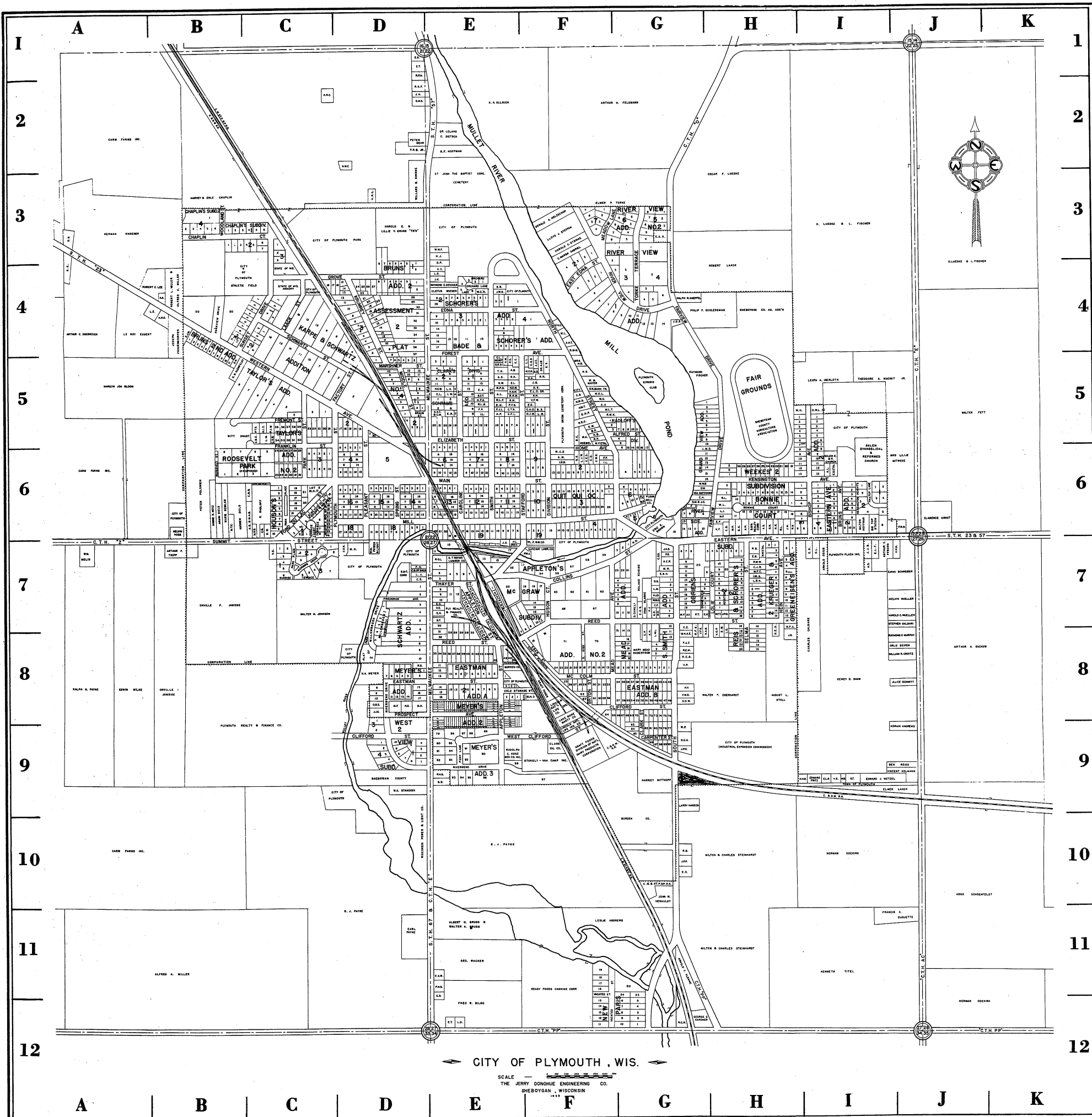
