CHAPTER NO. 11 ORDINANCES OF 1982

An Ordinance Detaching certain Lands from the Town of Plymouth and Annexing the Same to the City of Plymouth.

THE COMMON COUNCIL OF THE CITY OF PLYMOUTH DOES HEREBY ORDAIN AS FOLLOWS:

Section 1: Upon recommendation of the Plan Connission, the following described lands are hereby detached from the Town of Plymouth and attached to the City of Plymouth, to-wit:

A part of the NW4, SE4, Section 27, T15N, R21E, described as follows: Commencing 884.05 feet South of the NW corner of said NW4, SE4, thence East 176.5 feet; thence South 115 feet; thence West 176.5 feet to the West line of said NW4, SE4; thence North 115 feet to the beginning, containing .47 acres of land more or less.

Section 2: Said lands shall become a part of the Third Aldermanic District, and shall be zoned in the A Agricultural district.

Section 3: This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
