



NOTICE OF LITIGATION

TO

SECRETARY OF STATE

Pursuant to statute 66.026 of the Wisconsin Statutes, notice is hereby sent to the Secretary of State of an action now pending in the Circuit Court of Winnebago County contesting an annexation ordinance passed by the City of Menasha Common Council on September 11, 1965 which annexation ordinance contains the legal description and which description was incorporated in the Complaint as follows:

A part of Northeast 1/4 Section 11 - Town 20 North Range 17 East more particularly described as follows: Beginning on the South line of said Northeast 1/4 Section 11, 348.1 feet east of the Southwest corner said Northeast 1/4; thence easterly along said South line of the Northeast 1/4 1,448.2 feet to the centerline of State Trunk Highway 47 as presently laid out; thence Northeasterly along said centerline of State Trunk Highway 47 345 feet; thence westerly 1622.2 feet; thence Southerly 294.8 feet to the point of beginning.

Southeast 1/4 of the Northwest 1/4 Section 12, Town 20 North Range 17 East.

Southwest 1/4 of the Northwest 1/4 Section 12, Town 20 North Range 17 East.

That part of Section 11 Town 20 North Range 17 East described as follows: Beginning at the Southeast corner of the Southeast 1/4 of the Northeast 1/4 Section 11, Town 20 North Range 17 East; thence westerly along the South line of said Southeast 1/4 Northeast 1/4 Section 11 to a point on the North line of Lot 1 Block 8 first addition to Grove Sub-division which point is 172 feet west of the west line of London Street as presently laid out in the City of Menasha; thence South 29° 59' west to the centerline of Airport Road as platted in Grove Sub-division; thence North 60° 01' West to the centerline of State Trunk Highway 47 as presently laid out; thence Northeasterly along said centerline of State Trunk Highway 47 to the North line of the aforesaid Southeast 1/4 of the Northeast 1/4 Section; thence easterly to the Northeast corner of the said Southeast 1/4 of the Northeast 1/4 Section 11; thence southerly to the point of Beginning.

That part East half of the Northeast 1/4 Northwest 1/4 Section 12 described as follows: Beginning at the Northeast corner of the said Northeast 1/4 of the Northwest 1/4; run thence westerly along the North line of said Northeast 1/4 of the Northwest 1/4 604 feet; thence Southerly to a point in the South line of said Northeast 1/4 of the Northwest 1/4 which is 610 feet west of the Southeast corner of said Northeast 1/4 of Northwest 1/4; thence easterly 610 feet to said Southeast corner of the Northeast 1/4 of the Northwest 1/4; thence northerly to the point of beginning.

The east 307.50 feet of the west 2,011.19 feet of the North 373 feet of the Northwest 1/4 Section 12 Town 20 North Range 17 East.

The East one half of the Southeast 1/4 of the Southwest 1/4 Section 1, Town 20 North Range 17 East.

The Northeast 1/4 of the Southwest 1/4 Section 1, Town 20 North Range 17 East except the West 43.5 feet.

NOTICE OF LITIGATION

TO

SECRETARY OF STATE

Pursuant to statute 66.026, notice is hereby sent to the Secretary of State advising his office of litigation involving an annexation ordinance adopted by the Common Council of the City of Menasha on September 11, 1965.

That the legal proceedings served upon the City of Menasha by the plaintiffs describe property in dispute as follows:

And located in the Town of Menasha, Winnebago County, Wisconsin, to-wit - - - The southwest 1/4 of the northwest 1/4 of section 12, town 20 north, range 17 east; and the southeast 1/4 of the northwest 1/4 of section 12, town 20 north, range 17 east.

That said summons and complaint was served on the City of Menasha prior to the adoption of the annexation ordinance, together with a temporary restraining order which attempted to prohibit the City from enacting such ordinance. That such temporary restraining order was lifted by order of the court but the main action is still before the court.
