

A CHARTER ORDINANCE PERTAINING TO MEMBERSHIP OF THE WATER AND LIGHT COMMISSION.

Requested by Mayor Thom A. Ciske.

SECTION NO. 1: Pursuant to Chapter 66.01 of the Wisconsin Statutes, the City of Menasha hereby elects to amend its Charter Ordinance pertaining to membership of the Water and Light Commission.

SECTION NO. 2: Strike out that part of Chapter 2.26 pertaining to the Constitution of the Water and Light Commission which contains these words pertaining to membership:


"none of which shall be a member of the Common Council"


SECTION NO. 3: The Mayor shall be an ex-officio member of the Commission without voting privileges or ability to hold office until a suitable vacancy occurs in the said Commission. In that event the Council shall appoint the then incumbent Mayor and in turn each succeeding Mayor upon assuming the office to be a member of the Commission with full voting powers and all other powers, duties and responsibilities of a Commissioner. It is the intent of this Ordinance to keep the voting members of the Commission always at five (5), of which no more than two (2) may be elected officials of the City government.

SECTION NO. 4: This is a Charter Ordinance and shall take effect sixty (60) days after its publication unless within such sixty (60) day period a referendum petition is provided by Section 66.01 of the Wisconsin Statutes shall be filed. In which event, this ordinance shall not take effect until it shall have been submitted to a referendum vote of the electors and approved by a majority of the electors voting thereon.
