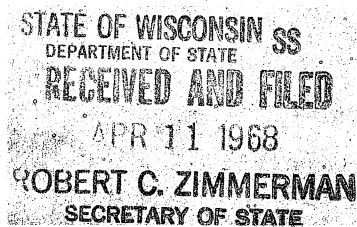

## CERTIFICATE OF ANNEXATION

I, R. V. Hauser, City Clerk-Comptroller of the City of Neenah, County of Winnebago, State of Wisconsin, DO HEREBY CERTIFY THAT the following described territory was detached from the Town of Neenah, County of Winnebago, and was annexed to the said City of Neenah, pursuant to Section 66.025 of the Wisconsin Statutes, by an Ordinance (Ordinance No. 41, Volume I.) adopted by the Common Council of the City of Neenah, at a regular meeting held March 20, 1968:

### Parcel One:

That part of the Northeast 1/4 of Section 34, T20N, R17E, in the Town of Neenah, Winnebago County, Wisconsin, described as follows:

Commencing on the North line of said Section 34, at a point 1658.8 feet of the Northwest corner of said Northeast 1/4, and on the centerline of Highway, which is the West branch of the extension of South Park Avenue, in the City of Neenah, thence S 21° - 37' W along the centerline of said Highway 391.5 feet to the place of beginning; Thence S 21° 37' W along the centerline of said Highway 125 feet; thence S 68° - 23' E 336 feet; thence N 21° - 37' E 125 feet; thence N 68° - 23' W to the place of beginning; less and excepting the Northwesterly 33 feet within the bounds of roadway; and


### Parcel Two:

That part of the Northeast 1/4 of Section 34, T20N, R17E, in the Town of Neenah, Winnebago County, Wisconsin, described as follows:

Commencing at a point on the N. line of Section 34 1658.8' E. of N.W. corner of N.E. 1/4; thence S. 21° 37' W. along the centerline of former Cty. Trk. Q, a distance of 244' to place of beginning. Thence S. 21° - 37' W. along the centerline of said Cty. Trk. 147.5'; thence 68° 23' E., a distance of 336'; thence Northwesterly to point of beginning of Section 34 T20N R17E Pt. NE 1/4, NE 1/4,

AN ORDINANCE ANNEXING CERTAIN LANDS TO THE CITY OF NEENAH,  
WISCONSIN.

The Common Council of the City of Neenah do ordain as follows:

Section 1. That pursuant to Section 66.021, Wisconsin Statutes, the following described territory contiguous to the City of Neenah, be, and the same hereby is, annexed to said City of Neenah, and the corporate limits of said City of Neenah are hereby extended so as to include said territory, described as follows: to-wit:

Parcel One:

That part of the Northeast 1/4 of Section 34, T20N, R17E, in the Town of Neenah, Winnebago County, Wisconsin, described as follows:  
Commencing on the North line of said Section 34, at a point 1658.8 feet East of the Northwest corner of said Northeast 1/4, and on the centerline of Highway, which is the West branch of the extension of South Park Avenue, in the City of Neenah, thence S 21° - 37' W along the centerline of said Highway 391.5 feet to the place of beginning; Thence S 21° - 37' W along the centerline of said Highway 125 feet; thence S 68° - 23' E 336 feet; thence N 21° - 37' E 125 feet; thence N 68° - 23' W to the place of beginning; less and excepting the Northwesterly 33 feet within the bounds of roadway; and

Parcel Two:

That part of the Northeast 1/4 of Section 34, T20N, R17E, in the Town of Neenah, Winnebago County, Wisconsin, described as follows:  
Commencing at a point on the N. line of Sec. 34 1658.8' E. of N. W. Corner of N. E. 1/4; thence S. 21° - 37' W. along the centerline of former Cty. Trk. Q, a distance of 244' to place of beginning. Thence S. 21° - 37' W. along the centerline of said Cty. Trk. 147.5'; Thence 68° - 23' E., a distance of 336'; North 21° - 37' East 147.5'; thence Northwesterly to point of beginning of Section 34 T20N R17E Pt. NE 1/4, NE 1/4.

Section 2. That the limits of the First Ward in the City of Neenah are hereby extended in such manner as to include said territory.

Section 3. That said territory is also annexed for school purposes and is hereby made a part of the City school district and subject to all of the laws governing the same.

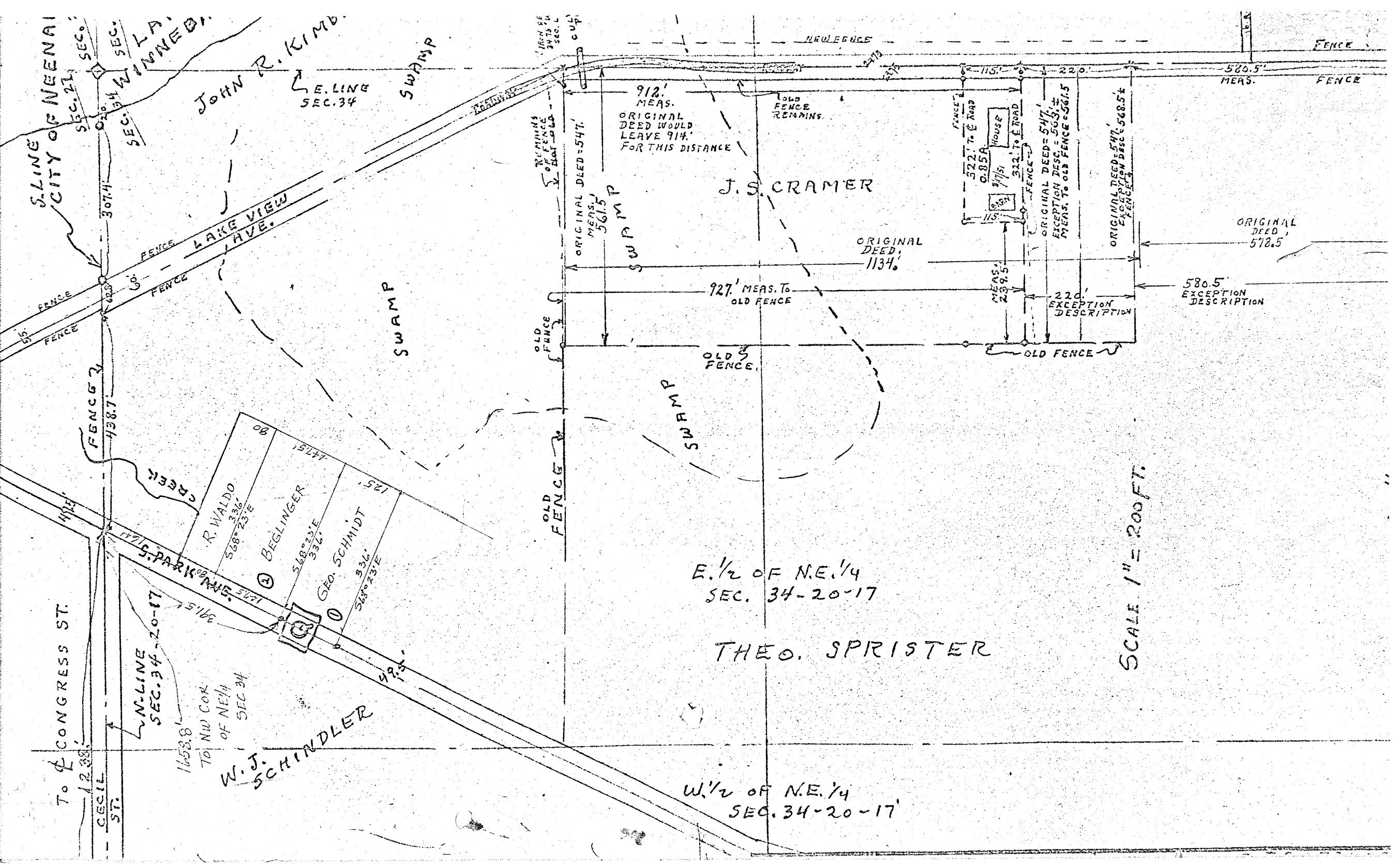
