CERTIFICATE OF ANNEXATION

I, J. J. Kraus, Director of Administration of the City of Neenah, County of Winnebago, State of Wisconsin, DO HEREBY CERTIFY that the following described property was detached from the Town of Neenah, County of Winnebago, and was annexed to said City of Neenah pursuant to Section 66.021 of the Wisconsin Statutes by an ordinance (Ordinance No. 438, Vol. 1) adopted by the Common Council of the City of Neenah at a regular meeting held on April 19, 1977.

Commencing at the North $\frac{1}{4}$ corner of Section Thirty-four (34), Township 20 North, Range 17 East: thence East along the section line and centerline of Cecil Street, 1658.80 ft.; thence South 21 31' 37" West along the centerline of South Park Avenue, as laid out in Wisconsin Highway Department project #4993-0-22, 1003.62 ft. (South 21 37' West, 1004.2 ft.) to the point of beginning of lands here described; thence South 21 31' 37" West along said centerline 182.12' to a point, thence North 88 00' 00" East, 861.60 ft. to a $\frac{3}{4}$ " steel bar set; thence 00 17' 56" East, (North 2 00' 00" West) 167.12' to a $\frac{3}{4}$ " steel bar set; thence South 88 00' 00" West, 795.60 ft. to the point of beginning. Reserving the West 33 ft. (as measured at right angles to the West Line) for roadway purposes.

I further certify that the plat attached hereto is a true and correct plat of the territory annexed and that the boundaries of the First Aldermanic District have been extended to include the above description and that the resident population of said territory is none.

WHEREAS, the Trustees of the Estate of Henry C. Krueger, who died owning all lands proposed to be annexed, have petitioned the Common Council for annexation of said lands; and,

WHEREAS, no electors reside in the proposed area to be annexed;

NOW, THEREFORE, the Common Council of the City of Neenah, Wisconsin, does ordain as follows:

Section 1. That the following described territory, in accordance with Section 66.021 of the Wisconsin Statutes, is hereby detached from the Town of Neenah and annexed to the City of Neenah, to-wit:

Commencing at the North 1/4 corner of Section Thirty-four (34), Township 20 North, Range 17 East; thence East along the section line and centerline of Cecil Street, 1658.80 ft.; thence South 21° 31' 37" West along the centerline of South Park Ave. as laid out in Wisconsin Highway Department project #4993-0-22, 1003.62 ft. (South 21° 37' West, 1004.2 ft.) to the point of beginning of lands here described; thence South 21° 31' 37" West along said centerline 182.12' to a point; thence North 88° 00' 00" East, 861.60 ft. to a 3/4" steel bar set; thence North 00° 17' 56" East, (North 2° 00' 00" West) 167.12' to a 3/4" steel bar set; thence South 88° 00' 00" West, 795.60 ft. to the point of beginning. Reserving the West 33 ft. (as measured at right angles to the West Line) for roadway purposes.

Section 2. The aforescribed territory is also annexed for school purposes and is hereby made a part of the City School District and subject to all the laws governing the same.

Section 3. All ordinances, or parts of ordinances, in conflict with the provisions of this ordinance are hereby repealed.

Section 4. This ordinance shall take effect and be in force from and after its passage and publication as provided by law.



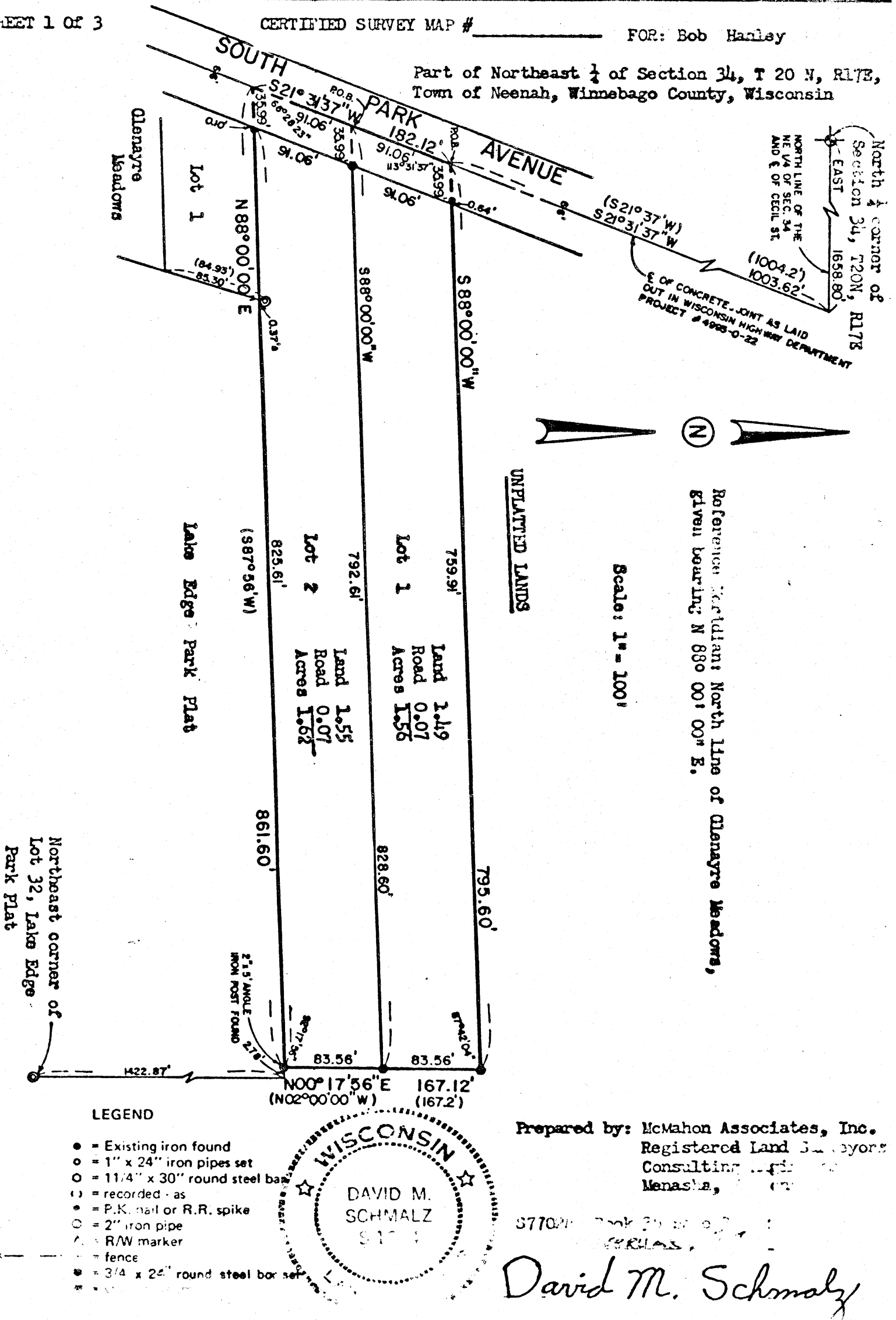
