CERTIFICATE OF ANNEXATION

I, Jean Moxon, Deputy City Clerk of the City of Neenah, County of Winnebago, State of Wisconsin, DO HEREBY CERTIFY that the following described property was detached from the Town of Neenah, County of Winnebago, and was annexed to the City of Neenah pursuant to Section 66.025 of the Wisconsin Statutes by an ordinance (Ordinance No. 502) adopted by the Common Council of the City of Neenah at a regular meeting held on January 17, 1979.

All that part of the SE quarter of Section 20, T 20 N, R 17 E, Town of Neenah, Winnebago County, Wisconsin, more fully described as follows:

Commencing at the East 1/4 corner of Section 20, T 20 N, R 17 E, City of Neenah, Winnebago County, Wisconsin; thence West along the East, West 1/4 line, 379.30 ft. to the point of beginning; thence continuing West along the East, West 1/4 line, 573.17+ ft.; thence South 205 ft.; thence West 400 ft.; thence North 205 ft. to a point on the East, West 1/4 line; thence West along the East, West 1/4 line, 153 ft.; thence South 741 ft.; thence West 615 ft.; thence North 213 ft.; thence West 495 ft. to a point on the North-South 1/4 line; thence South along the North-South 1/4 line to a point, 1,059.73 ft. North of the South 1/4 corner; thence North 73° 20' 59" East, 3.51 ft. to an existing 1 inch iron pipe and thence continue North 73° 20' 59" East, 161.77 ft. to an existing 1 inch iron pipe; thence South 16° 34' 23" East, 405.68 ft. to an existing iron pipe on the Northerly line of Oakridge Road (formerly County Trunk "S"); thence continuing South 16° 34' 23" East to the centerline of Oakridge Road; thence Northeasterly along the centerline of Oakridge Road to a point on the centerline of Oakridge Road, 1009.5 ft. West of the East line of said Section (measured along the centerline of Main Street and Oakridge Road); thence Easterly along the centerline of Oakridge Road and Main Street to the centerline of former County Trunk "O" (Ramp Road); thence Northerly along the centerline of former County Trunk "O" (Ramp Road), 132 ft.; thence East to a point that is 664.29 ft. West of the East line of said Section 20; thence North 286.9 ft.; thence East and parallel with the North line of the East half of the SE 1/4, 330.09 ft.; thence Northerly along the Easterly right-of-way line of US Highway 41 to the point of beginning.





## ORDINANCE NO. 502

## A GENERAL ORDINANCE OF THE CITY OF NEENAH PERTAINING TO THE ANNEXATION OF OAK HILL CEMETERY.

The Common Council of the City of Neenah do ordain as follows:

SECTION 1. That pursuant to Section 66.025, Wisconsin Statutes, the following described territory contiguous to the City of Neenah, and presently in the Town of Neenah, be and the same hereby is, annexed to the City of Neenah, and the corporate limits of said City of Neenah are hereby extended so as to include said territory, described as follows; to-wit:

All that part of the SE quarter of Section 20, T 20 N, R 17 E, Town of Neenah, Winnebago County, Wisconsin, more fully described as follows:

Commencing at the East 1/4 corner of Section 20, T 20 N, R 17 E, City of Neenah, Winnebago County, Wisconsin; thence West along the East, West 1/4 line, 379.30 ft. to the point of beginning; thence continuing West along the East, West 1/4 line, 573.17 $\frac{1}{2}$  ft.; thence South 205 ft.; thence West 400 ft.; thence North 205 ft. to a point on the East, West 1/4 line; thence West along the East, West 1/4 line, 153 ft.; thence South 741 ft.; thence West 615 ft.; thence North 213 ft.; thence West 495 ft. to a point on the North-South 1/4 line; thence South along the North-South 1/4 line to a point, 1,059.73 ft.
