
I, Jean Moxon, City Clerk of the City of Neenah, County of Winnebago, State of Wisconsin, DO HEREBY CERTIFY that the following described property was detached from the Town of Neenah, County of Winnebago, and was annexed to the City of Neenah pursuant to Section 66.021 of the Wisconsin Statutes by an ordinance (Ordinance No. 868) adopted by the Common Council of the City of Neenah at a regular meeting held on September 6, 1989.

Part of the Northeast 1/4 and Northwest 1/4 of Section 29, Town 20 North, Range 17 East, Town of Neenah, Winnebago County, Wisconsin described as follows: Beginning at the North 1/4 corner of Section 29; thence South 89°-58'-01" East, along the Section Line, 1645.35 feet; thence South 05°-25'-36" West, 182 feet more or less to the South right-of-way line of North Plummer Court; thence Easterly along said South right-of-way line to the Easterly right-of-way line of U.S. Highway "41"; thence Southerly along said Easterly right-of-way line to a point 1000 feet South of the North Section Line; thence Westerly, parallel with the North section line and 1000 feet therefrom, to a point 620 feet East of the West right-of-way line of Tullar Road; thence Northerly parallel with said West right-of-way line to a point 302' South of the South right-of-way line of North Plummer Court; thence West parallel with said South right-of-way line to the Southeast corner of Lot 1 of Certified Survey Map No. 1972, recorded as Document No. 718316, Winnebago County Register of Deeds; thence northerly along the East line of said Lot 1 to the said South right-of-way line of North Plummer Court; thence West along said South right-of-way line and extension thereof to the West right-of-way line of Tullar Road; thence Northerly along said West right-of-way line to the North section line; thence Easterly to the North 1/4 corner of Section 29 and point of beginning.

I further certify that the plat attached hereto is a true and correct plat of the territory annexed and that the boundaries of the Seventh Aldermanic District have been extended to include the above description and at the time of the original annexation there were 0 residents in population in said territory.

ORDINANCE NO. 868

AN ORDINANCE ANNEXING CERTAIN LANDS TO THE CITY OF NEENAH, WISCONSIN.

The Common Council of the City of Neenah do ordain as follows:


SECTION 1. That pursuant to Section 66.021 of the Wisconsin Statutes, the following described territory contiguous to the City of Neenah, be and the same hereby is, annexed to said City of Neenah and the corporate limits of said City of Neenah are hereby extended so as to include said territory, which is described as follows, to-wit:

Part of the Northeast 1/4 and Northwest 1/4 of Section 29, Town 20 North, Range 17 East, Town of Neenah, Winnebago County, Wisconsin described as follows: Beginning at the North 1/4 corner of Section 29; thence South 89°-58'-01" East, along the Section Line, 1645.35 feet; thence South 05°-25'-36" West, 182 feet more or less to the South right-of-way line of North Plummer Court; thence Easterly along said South right-of-way line to the Easterly right-of-way line of U.S. Highway "41"; thence Southerly along said Easterly right-of-way line to a point 1000 feet South of the North Section Line; thence Westerly, parallel with the North section line and 1000 feet therefrom, to a point 620 feet East of the West right-of-way line of Tullar Road; thence Northerly parallel with said West right-of-way line to a point 302' South of the South right-of-way line of North Plummer Court; thence West parallel with said South right-of-way line to the Southeast corner of Lot 1 of Certified Survey Map No. 1972, recorded as Document No. 718316, Winnebago County Register of Deeds; thence northerly along the East line of said Lot 1 to the said South right-of-way line of North Plummer Court; thence West along said South right-of-way line and extension thereof to the West right-of-way line of Tullar Road; thence Northerly along said West right-of-way line to the North section line; thence Easterly to the North 1/4 corner of Section 29 and point of beginning.

SECTION 2. That said territory shall be temporarily zoned I-1, Planned Business Center District.

SECTION 3. That the limits of Ward 13 of the Seventh Aldermanic District in the City of Neenah are hereby extended in such manner so as to include said territory.

SECTION 4. That all ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.



SECTION 5. That this ordinance shall be in full force and effect from and after its passage and date of publication.
