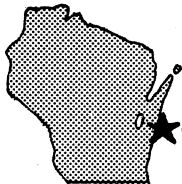

DESCRIPTION OF TERRITORY ANNEXED

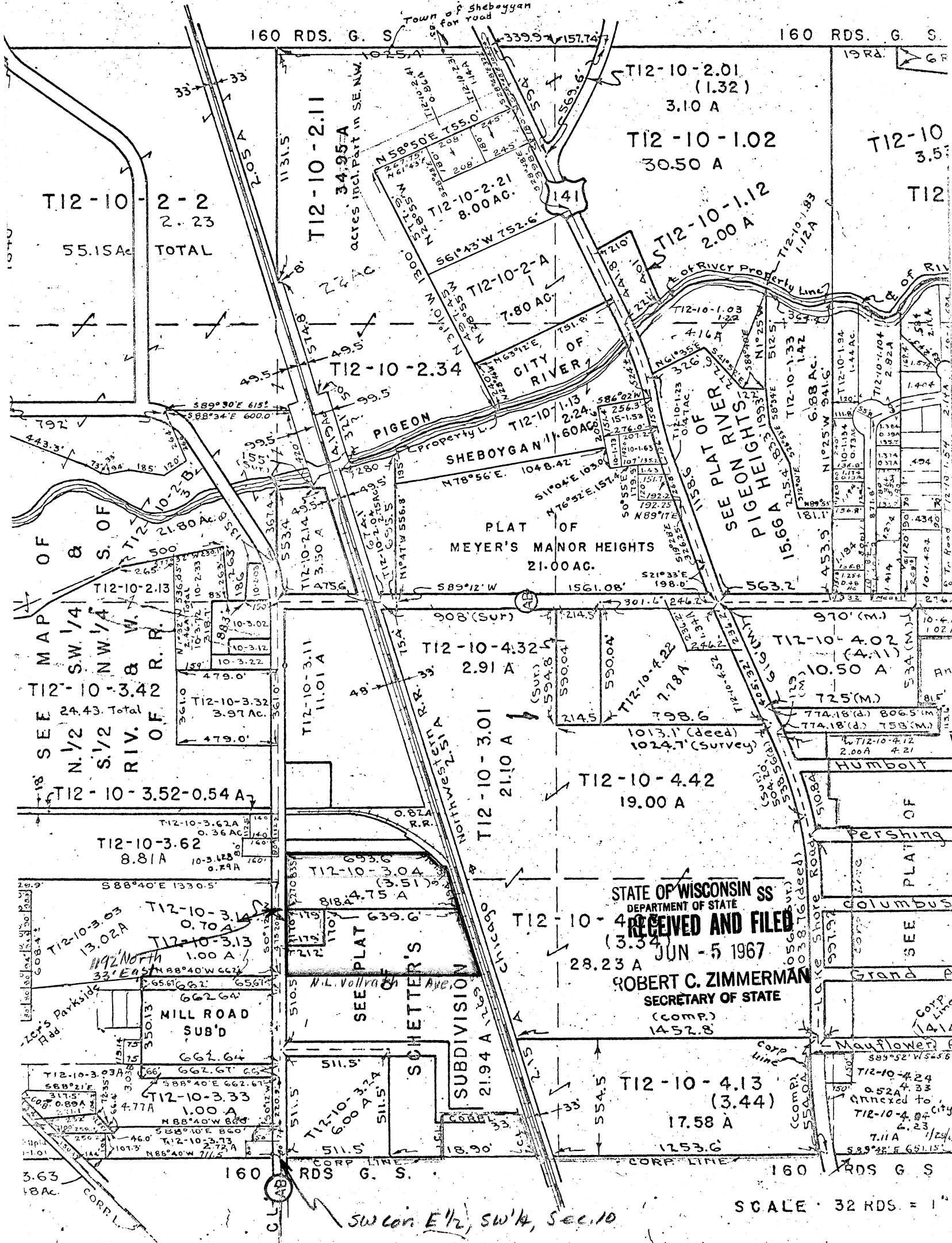
Part of the east one half (E $\frac{1}{2}$) of the southwest quarter
(SW $\frac{1}{4}$) of Section 10, Township 15 North, Range 23 East,
commencing 1192 ft. north and 33 ft. east of the south-
west corner of said east one half (E $\frac{1}{2}$), thence north
270.835 ft., thence east 693.9 ft. to the west right-
of-way line of spur track, thence southeast along said
right-of-way line 107.3 ft., thence northeast 9 ft. to
right-of-way line of main track, thence southeast on
said right-of-way line 522 ft. more or less to the north
line of Vollrath Ave., thence west along the north line
of said Avenue to the east line of Mill St., thence
north 310 ft. more or less to the point of beginning,
except the north 119 ft. thereof.
