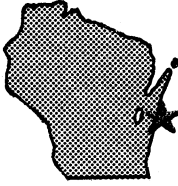

AN ORDINANCE annexing territory from the Town of Sheboygan to the City of Sheboygan, situated west of North 30th St. between North Ave. and Main Ave.

THE MAYOR AND COMMON COUNCIL OF THE CITY OF SHEBOYGAN DO ORDAIN AS FOLLOWS:

Section 1. In accordance with the provisions of Section 66.021 (12) of the Wisconsin Statutes, and a petition for direct annexation filed with the City Clerk on March 29, 1978, signed by the owners of all the land in the area sought to be annexed, and pursuant to the certification of the City Clerk that no electors reside therein, the following described area in the Town of Sheboygan, Sheboygan County, Wisconsin, is hereby annexed to the City of Sheboygan:

Part of the Northwest Quarter, Northeast Quarter (NW $\frac{1}{4}$ NE $\frac{1}{4}$) Section Sixteen (16), Town Fifteen (15) North, Range Twenty-three (23) East, commencing three hundred thirty (330) ft. west of the east line of said Quarter and two hundred fifty-one and six tenths (251.6) ft. north of the center line of Main Ave., thence west one hundred sixty-five (165) ft., thence north eighty-five and one hundredth (85.01) ft., thence east one hundred ninety-five (195) ft. to the east line of North 30th St., thence south eighty-five and one hundredth (85.01) ft., thence west thirty (30) ft. to beginning.

Section 2. From and after the date of the passage of this ordinance, the territory described in Section 1 of this ordinance shall be a part of the City of Sheboygan for any and all purposes provided by law, and all persons coming or residing within such territory shall be subject to all ordinances and regulations governing the City of Sheboygan.

Section 3. The territory described in Section 1 of this ordinance is hereby made a part of the 7th Ward, 1st Precinct of the City of Sheboygan.

Section 4. The territory described in Section 1 of this ordinance is hereby zoned R-1 Residential

Section 5. All ordinances or parts thereof in conflict with the provisions of this ordinance are hereby repealed to the extent of such conflict, and this ordinance shall be in effect from and after its passage and publication.

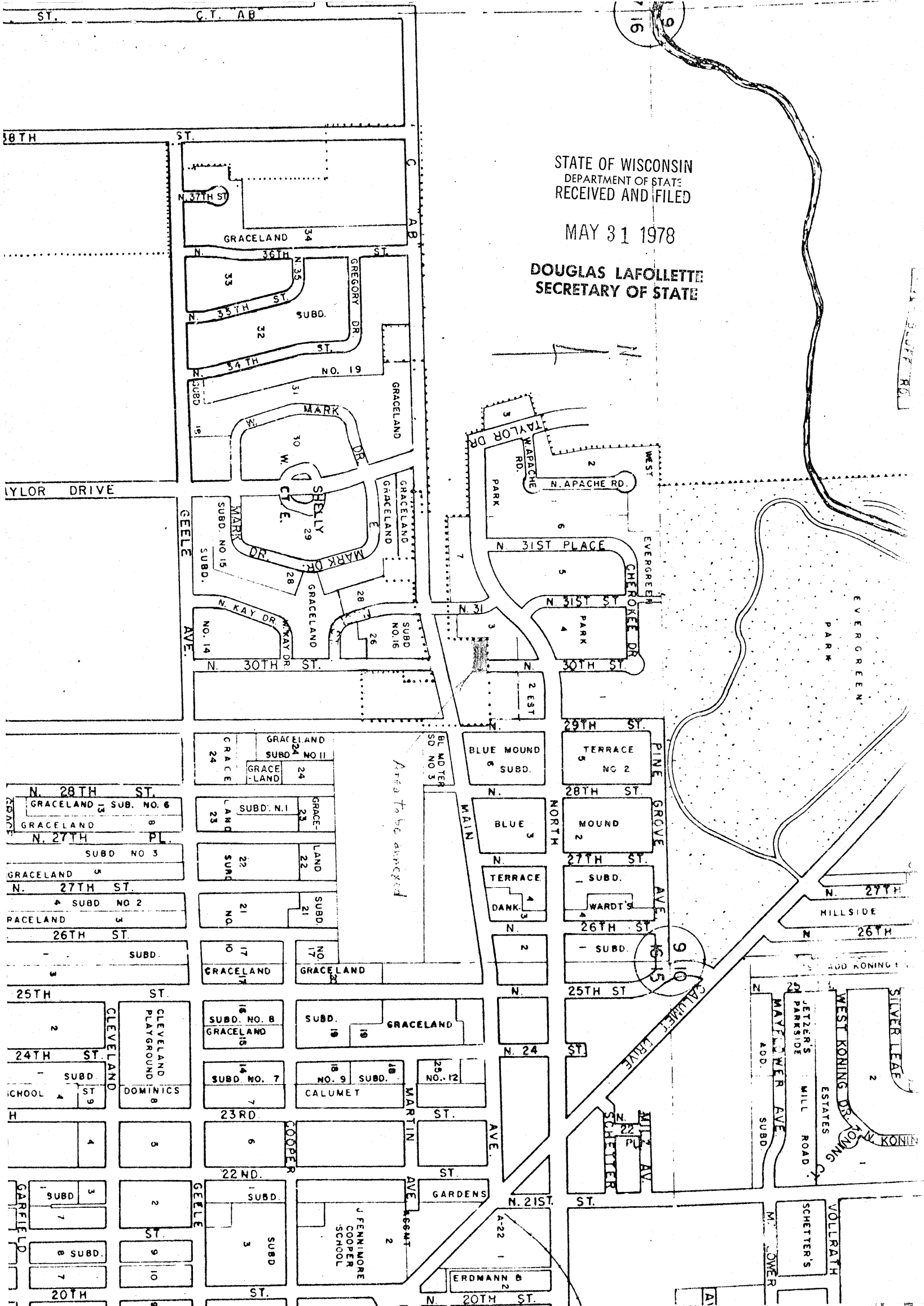
