

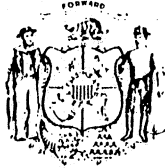

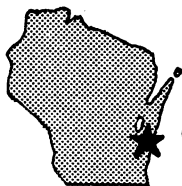

AN ORDINANCE annexing territory from the Town of Sheboygan to the City of Sheboygan located on the north side of Main Ave., east of N. 40th St.

THE COMMON COUNCIL OF THE CITY OF SHEBOYGAN DO ORDAIN AS FOLLOWS:

Section 1. In accordance with Section 66.021 of the Wisconsin Statutes and a petition for direct annexation filed with the City Clerk on the 15th day of October, 1986, signed by the owner of all the real property in the area in which no electors reside, the following described territory in the Town of Shboygan, Sheboygan County, Wisconsin, is hereby annexed to the City of Sheboygan:

Part of the NW, NW, Section 16, T15N, R23E, commencing in the center of Main Ave. 184.08' and N. 88°-42' E., 153.3' from SW corner of said 1/4, thence N. 88°-42' E., 80', S. 1°-18' E., 154.05', S. 88°-42' W., 80', thence N. 1°-18' W., 154.05' to beginning, being a tract containing .28 acres of land

Section 2. From and after the effective date of this ordinance, the territory described in Section 1 shall be a part of the City of Sheboygan for any and all purposes provided by law, and all persons coming or residing in such territory shall be subject to all ordinances, rules and regulations governing the City of Sheboygan.

Section 3. The territory described in Section 1 of this ordinance is hereby made a part of the 13th Ward, 7th Aldermanic District, of the City of Sheboygan.

Section 4. The territory described in Section 1 of this ordinance is hereby temporarily zoned R-1 Residential.
