AN ORDINANCE annexing territory from the Town of Sheboygan to the City of Sheboygan located south of Erie Ave. between N. 39th St. and N. 40th St.

THE COMMON COUNCIL OF THE CITY OF SHEBOYGAN DO ORDAIN AS FOLLOWS:

Section 1. In accordance with Section 66.021 of the Wisconsin Statutes and a petition for direct annexation filed with the City Clerk on the 14th day of March, 1988, signed by all of the owners of real property and all of the electors in the area, the following described territory in the Town of Sheboygan, Sheboygan County, Wisconsin, is hereby annexed to the City of Sheboygan:

Being part of W 1/2 of SW 1/4, Section 21, and part of SE 1/4, Section 20, T15N, R23E

Commencing at the NW corner of the intersection of Erie Ave. and W. 38th St., thence SWly along the Nly line of Erie Ave. (approx. 200') to the point of beginning, said point being the line 82.3' E. of the W.L. of Lot 14, Greendale Park, projected Nly to the Nly line of Erie Ave., thence SWly along the N.L. of Erie Ave. (approx. 520') to a point, said point being the line 153.7' E. of the W.L. of Lot 16, Greendale Park, projected Nly to the N.L. of Erie Ave., thence Sly and 153.7' E. of the W.L. of Lot 16 to the S.L. of Section 20, thence Ely along the S.L. of Sections 20 and 21 to a point 102.3' E. of the E.L. of Lot 16, Greendale Park, thence Nly and 102.3' E. of the E.L. of Lot 16, Greendale Park, to a point which is 165' N. of the N.L. of Lot 27, Greendale Park, thence Ely and 165' N. of the N.L. of Lot 27, Greendale Park, to a point 82.3' E. of the W.L. of Lot 14, Greendale Park, thence Nly to the point of beginning, being a tract of land containing 8.5 acres, more or less

Section 2. From and after the effective date of this ordinance, the territory described in Section 1 shall be a part of the City of Sheboygan for any and all purposes provided by law, and all persons coming or residing in such territory shall be subject to all ordinances, rules and regulations governing the City of Sheboygan.



Section 3. The territory described in Section 1 of this ordinance is hereby made a part of the 6th Ward, 3rd Aldermanic District, of the City of Sheboygan.

Section 4. All ordinances or parts thereof in conflict with the provisions of this ordinance are hereby repealed to the extent of such conflict, and this ordinance shall be in effect from and after its passage and publication.
