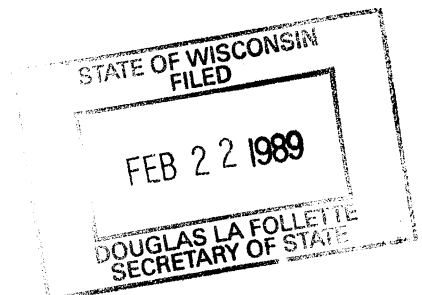

AN ORDINANCE annexing territory from the Town of Sheboygan to the City of Sheboygan located at the southeasterly corner of N. 8th St. and Eisner Ave.

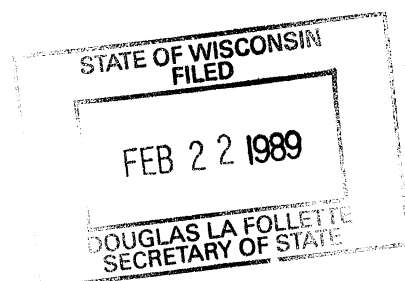
THE COMMON COUNCIL OF THE CITY OF SHEBOYGAN DO ORDAIN AS FOLLOWS:

Section 1. In accordance with Section 66.021 of the Wisconsin Statutes and a petition for direct annexation filed with the City Clerk on the 10th day of January, 1989, signed by all of the owners of the real property in the area in which no electors reside, the following described territory in the Town of Sheboygan, Sheboygan County, Wisconsin, is hereby annexed to the City of Sheboygan:

Part of Government Lot 3 of Section 11, T15N, R23E, beginning on the S.L. of Eisner Ave. and 23.91' E. of the NW corner of Tract 3 of a C.S.M. recorded in Volume 8, Page 125, thence Sly to the SW corner of tract 3 of said C.S.M., thence Sly along the Wly boundary of said C.S.M. to its intersection with the Nly boundary of a C.S.M. recorded in Volume 7, Page 199, thence Wly along the Nly boundary of said C.S.M. to the Ely line of N. 8th St., thence Nly along said E.L. to the N.L. of Eisner Ave., thence Ely on said N.L. a distance of 180', thence Sly to the point of beginning, being a tract containing 1.33 acres, more or less

Section 2. From and after the effective date of this ordinance, the territory described in Section 1 shall be a part of the City of Sheboygan for any and all purposes provided by law, and all persons coming or residing in such territory shall be subject to all ordinances, rules and regulations governing the City of Sheboygan.

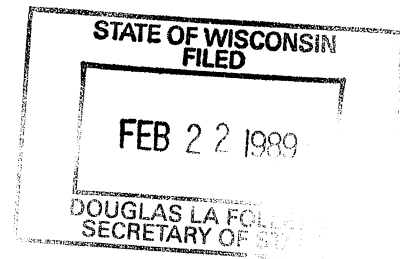
Section 3. The territory described in Section 1 of this ordinance is hereby made a part of the 1st Ward, 1st Aldermanic District, of the City of Sheboygan.
