
AN ORDINANCE annexing territory from the Town of Sheboygan to the City of Sheboygan situated on the north side of Mill Rd., east of N. 29th St.

THE COMMON COUNCIL OF THE CITY OF SHEBOYGAN DO ORDAIN AS FOLLOWS:

Section 1. In accordance with §66.021 of the Wisconsin Statutes and a petition for direct annexation filed with the City Clerk on the 15th day of February, 1990, signed by all of the owners of the real property in the area in which no electors reside, the following described territory in the Town of Sheboygan, Sheboygan County, Wisconsin, is hereby annexed to the City of Sheboygan:

Part of the S. 1/2 of the NE 1/4 of Sec. 9, T15N, R23E, described as:

Commencing at the SE corner of Lot 3, Blk. 1, Ribich Pine View Heights Subd., thence S. 0°-02' E. along the extended E.L. of said Lot 3 to the S.L. of the NW 1/4 of the NE 1/4 of said Sec. 9 to the true point of beginning, thence continuing S. 0°-02' E., to a point that is 100' S. 0°-02' E. of the SE corner of said Lot 3, Blk. 1, Ribich Pine View Heights, thence S. 89°-37'-00" W., 135.00' to the E. r.o.w. of proposed N. 29th St., thence SEly 163.62' along an arc of a curve to the right with a radius of 637.73', a chord bearing of S. 07°-23'-00" E., and a chord length of 163.17' to a meander corner which is 20' more or less S. 75°-16' W. from the center line of a drainage ditch, thence N. 75°-16'-00" E., 40.00' to a meander corner which is 20' more or less N. 75°-16' E. from center line of said ditch, thence S. 37°-30'-27" E., 84.90' along said meander line to a meander point that is 20' more or less NEly from the center line of said ditch, thence S. 58°-39'-55" E., 131.13' along said meander line to a point in the S. r.o.w. line of Mill Rd., thence NEly along said S. r.o.w., 11.36' along an arc of a curve to the left with a radius of 368.94', a chord bearing N. 51°-



53'-55" E., and a chord distance of 11.36', thence NEly along said S. r.o.w. line, 36.56' along an arc of a curve to the right with a radius of 317.00', a chord bearing of N. 58°-50'-21" E., and a chord length of 86.29', thence N. 00°-02'-00" W., 304.16', thence N. 89°-37'-00" E., 130.00' to the NE corner of a C.S.M. recorded in Vol. 5, Page 157, said point also being the SW corner of Lot 15, Blk. 6, 2nd Add. to Ribich Pine View Heights Subd., said point also being the NW corner of Lot 9, Blk. 6, 1st Add. to Ribich Pine View Heights Subd., thence N. 0°-02' W., 30' more or less to the N.L. of the S. 1/2 of the NE 1/4 of said Sec. 9, thence W. along said N.L. to the point of beginning, including that land lying between said meander line and the center line of said ditch, being a tract of land containing 2.2 acres, more or less

Section 2. From and after the effective date of this ordinance, the territory described in Section 1 shall be a part of the City of Sheboygan for any and all purposes provided by law, and all persons coming or residing in such territory shall be subject to all ordinances, rules and regulations governing the City of Sheboygan.

Section 3. The territory described in Section 1 of this ordinance is hereby made a part of the 7th Ward, 13th Aldermanic District, of the City of Sheboygan.

Section 4. Adoption of this Annexation Ordinance constitutes acceptance of the above-referenced petition for direct annexation by the Common Council.

Section 5. All ordinances or parts thereof in conflict with the provisions of this ordinance are hereby repealed to the extent of such conflict, and this ordinance shall be in effect from and after its enactment.


