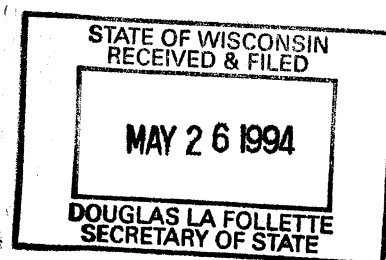

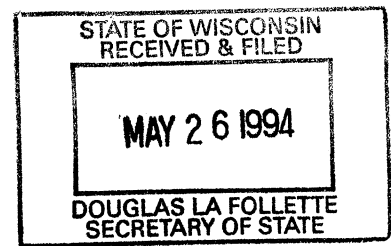

AN ORDINANCE annexing territory from the Town of Wilson to the City of Sheboygan situated in the vicinity of the southeast corner of Marvery Rd. and S. 18th St.

THE COMMON COUNCIL OF THE CITY OF SHEBOYGAN DO ORDAIN AS FOLLOWS:

Section 1. In accordance with Sec. 66.021 of the Wisconsin Statutes and a petition for direct annexation filed with the City Clerk on the 14th day of April, 1994, signed by the owners of all the real property and all of the electors in the area, the following described territory in the Town of Wilson, Sheboygan County, Wisconsin, is hereby annexed to the City of Sheboygan:

Sec. 3, T14N, R23E being Lot 6, Blk. 5, Fifth Addition to Plainwood Subdivision plus that portion of Marvery Rd. adjacent to the north side of Lot 6, being a tract containing 0.848 acres.

Section 2. From and after the effective date of this ordinance, the territory described in Section 1 shall be a part of the City of Sheboygan for any and all purposes provided by law, and all persons coming or residing in such territory shall be subject to all ordinances, rules and regulations governing the City of Sheboygan.

Section 3. The territory described in Section 1 of this ordinance is hereby made a part of the 9th Ward, 5th Aldermanic District, of the City of Sheboygan.

Section 4. All ordinances or parts thereof in conflict with the provisions of this ordinance are hereby repealed to the extent of such conflict, and this ordinance shall be in effect from and after its passage and publication.

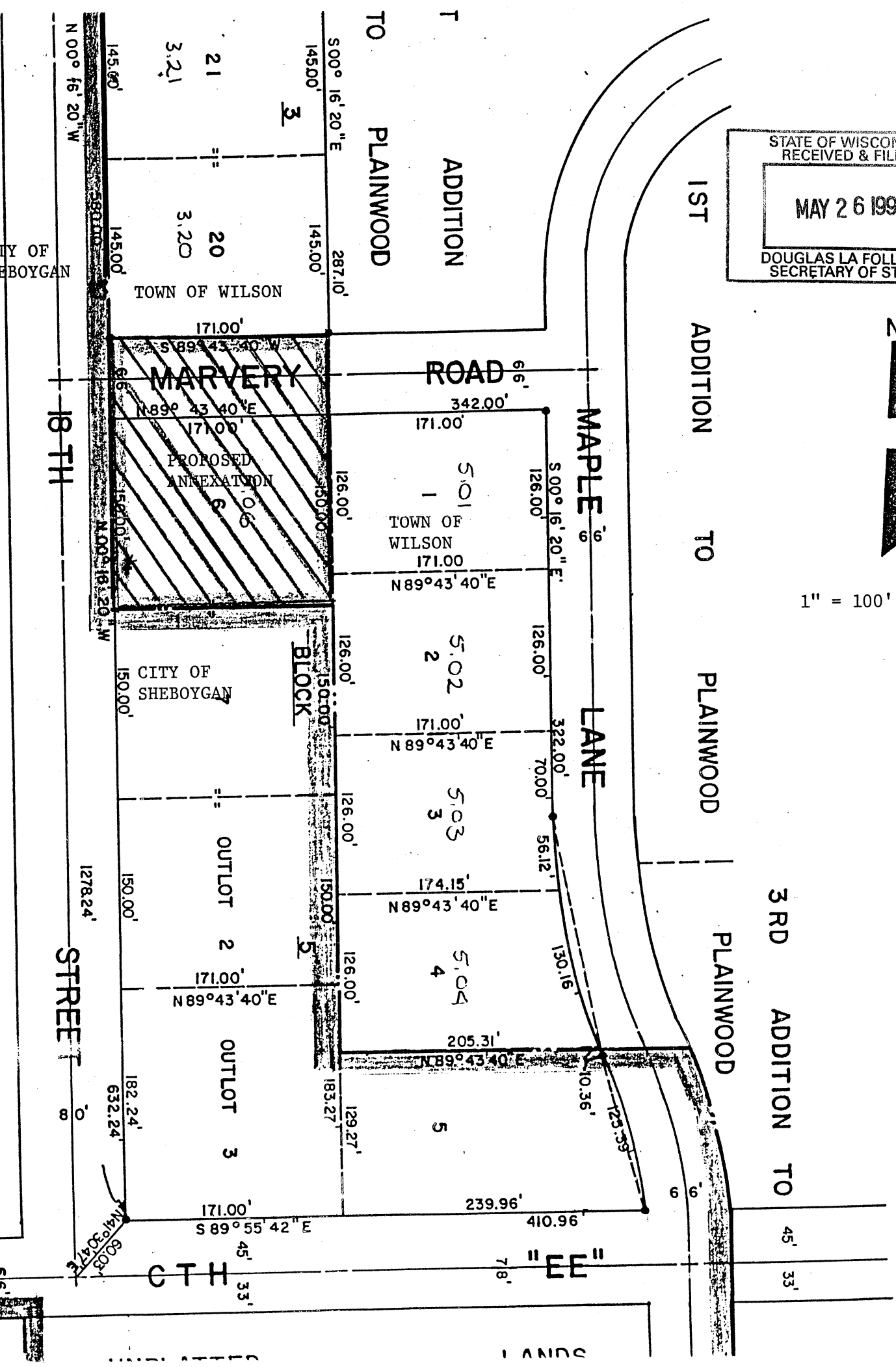
