

AN ORDINANCE

By Alderman Alwin:

An ordinance creating subsection (5) of section 15.11 of the General Ordinances of the City of Madison entitled "Annexation of Territory" and being a part of the chapter entitled "Wards and Precincts."

Whereas, a petition has been made and presented in writing to the Mayor and Common Council of the City of Madison, signed by the owners of all the taxable property within the limits of the territory hereinafter described, now therefore

The Common Council of the City of Madison do ordain as follows:

1. Subsection (5) of section 15.11 of the General Ordinances of the City of Madison of the City of Madison is hereby created to read:

"15.11 (5). That there is hereby detached from the Town of Blooming Grove, Dane County, Wisconsin, and annexed to the Sixteenth Ward of the City of Madison, Dane County, Wisconsin, certain real estate lying near to said city and described as follows:

"A parcel of land lying in and being a part of the West Half ($W\frac{1}{2}$) of the Northwest Quarter ($NW\frac{1}{4}$) of Section Nine (9) and the East Half of the Northeast Quarter ($E\frac{1}{2}-NE\frac{1}{4}$) of Section Eight (8), both in Town Seven (7) North, Range Ten (10) East, Dane County, Wisconsin, described more fully as follows:

Beginning at a point on the East line of the West half ($W\frac{1}{2}$) of the Northwest Quarter ($NW\frac{1}{4}$) of Section 9, Town 7 North, Range 10 East, which is 514.2 feet North 0 degrees 15' East from an iron stake marking the Northwest corner of Block S, Lake Edge Park plat now of record; thence North 0 degrees 15' East on said line 1113.5 feet to the Southerly line of Chicago & Northwestern Railroad right-of-way; thence North 58 degrees 06' west along said right-of-way 483.9 feet; thence South 62 degrees 41' West 1241.7 feet to the center of Atwood Avenue (so-called); thence along the center line South 33 degrees 39' East 217.3 feet to beginning of curve; thence along said center line on a 4 degree 49 $\frac{1}{2}$ ' curve to the right for a distance of 386.8 feet to the end of said curve; thence along said center line South 15 degrees 21' East 295.2 feet; thence North 89 degrees 12' East 1150.6 feet to the point of beginning, excepting therefrom a parcel in the Southwest corner sold to Edward Voges described by deed recorded in Vol. 396 of Deeds, page 241 in the office of the Register of Deeds for Dane County, Wisconsin."

Said territory and all persons and things coming within or residing within shall be and hereby are declared to be subject to all the rules, regulations and ordinances governing said ward in the City of Madison.

2. This ordinance shall be in effect from and after its passage and publication and in accordance with the provisions

of paragraph (b) of subsection (1) of section 62.07 of the Wisconsin Statutes, but the same shall not operate to detach or annex the territory mentioned herein until after the expiration of ninety days from the date of the passage of this ordinance by the Common Council.
