AN ORDINANCE

By Alderman William Boyle:

An Ordinance creating subsection (7) of section 15.11 of the General Ordinances of the City of Madison entitled "Annexation of Territory" and being a part of the Chapter entitled "Wards and Precincts".

Whereas a petition has been made and presented in writing to the Mayor and Common Council of the City of Madison signed by a majority of the electors in such adjacent territory and by the owners of more than one-half of the taxable property therein according to the 1940 tax roll within the limits of the territory hereinafter described,

Now, Therefore, The Common Council of the City of Madison do ordain as follows:

1. Subsection (7) of section 15.11 of the General Ordinances of the City of Madison is hereby created to read:

"15.11 (7). That there is hereby detached from the Town of Blooming Grove, Dane County, Wisconsin, and annexed to the Seventeenth Ward of the City of Madison, Dane County, the following described real estate:

'Lots One (1) to Eight (8) inclusive of Block One (1), Lots One (1) to Ten (10) inclusive, Block Two (2) Rethke's Subdivision, or part of the Northwest One-quarter (NW $\frac{1}{4}$) of Section Five, Town Seven North, Range Ten East; Lots Three Hundred (300) to Three Hundred Forty-six (346) inclusive, Clyde A. Gallagher's Replat of Lot One Hundred Nine (109) Farwell's Addition to the City of Madison (also known as parts of Lots Three Hundred Ten, Eleven, Twelve, Fifteen, Twenty-eight, Twenty-nine, Thirty and Thirty-one (310, 311, 312, 315, 328, 329, 330 and 331), and all of Lots Three Hundred Sixteen to Three Hundred Twenty-seven (316 to 327) inclusive of plan of Farwell's Eastern Addition to the City of Madison) - all being part of the Northwest One-quarter (NW $\frac{1}{4}$) of section 5, Town 7 North, Range 10 East.'

Said territory and all persons and things coming within or residing within shall be and hereby are declared to be subject to all the rules, regulations and ordinances governing said ward in the City of Madison."

2. This ordinance shall be in effect from and after its passage and publication and in accordance with the provisions of paragraph (b) of subsection (1) of section 62.07 of the Wisconsin Statutes, but the same shall not operate to detach or annex the territory mentioned herein until after the expiration of ninety days from the date of the passage of this ordinance by the common council.
