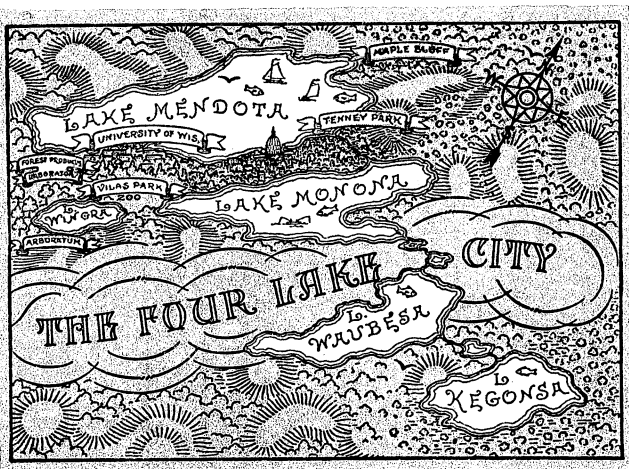



Part of the Northwest 1/4 of the Southwest 1/4 of Section 35, Town 7 North, Range 9 East, Town of Madison, Dane County, Wisconsin, more fully described as follows:

Beginning at a point in the limits line of the City of Madison, said point being 422 feet North and 495 feet east of the Southeast corner of the West 15 acres of the Northwest 1/4 of the Southwest 1/4 of Section 35, Town 7 North, Range 9 East, Town of Madison, Dane County, Wisconsin, said point also being the Northeast corner of Lot 8 of the Hrubesky Commercial Plat, a recorded plat in sections 34 and 35, Town 7 North, Range 9 East, Town of Madison, Dane County, Wisconsin; thence North 440 feet; thence West 342 feet; thence Southwesterly 454 feet; thence East 396 feet to the point of beginning, it being the intent to describe property conveyed to Edward Koster and Jessie E. Koster, by instrument No. 736681 on file in the office of the Dane County Register of Deeds in Volume 489, Page 429.
