



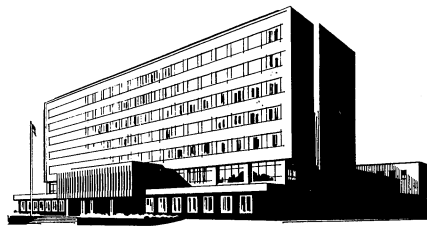



Part of Outlot "A", Plat of Highwood, a recorded plat in the Southeast 1/4 of the Northwest 1/4 of Section 21, Town 7 North, Range 10 East, Town of Blooming Grove, Dane County, Wisconsin, more fully described as follows:

Beginning at a point in the limits line of the City of Madison, said point being the Southwest corner of Lot 31, Plat of Highwood, a recorded plat in the Southeast 1/4 of the Northwest 1/4 of Section 21, Town 7 North, Range 10 East, Dane County, Wisconsin; thence South 25 feet along the West line of Outlot "A", as platted in said plat; thence East 130 feet on a line that is parallel to and 25 feet South of the South line of said Lot 31 to its point of intersection with the Southerly prolongation of the West line of Groveland Terrace, as platted in said plat; thence South 72 feet along the Southerly prolongation of the West line of Groveland Terrace; thence North 87°-57' East 190 feet; thence North 03°-19' West to the Southeast corner of Lot 32 of said plat; thence South 87°-57' West 130 feet; thence North 70°-52' West 64.9 feet; thence South 87°-57' West 130 feet to the point of beginning.

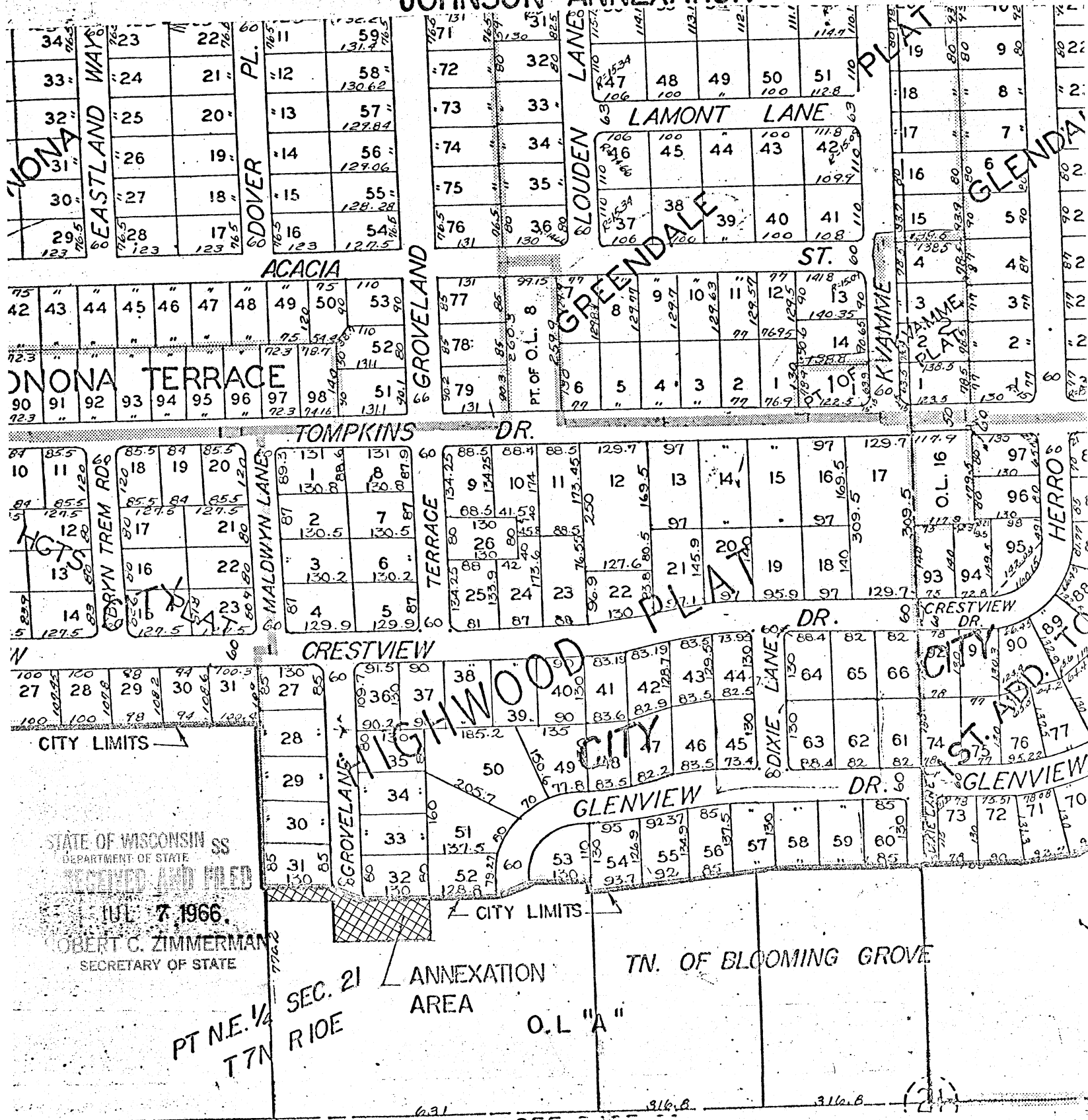
