



Part of Section 1, Town 6 North, Range 8 East, Town of Verona, Dane County, Wisconsin, more fully described as follows:

Beginning at a point in the limits line of the City of Madison, said point being on the West line of the East 1/2 of the Northeast 1/4 of Section 1, Town 6 North, Range 8 East, Town of Verona, Dane County, Wisconsin and 2094.13 feet South of the North line of said Section 1; measured along the said West line; thence North 89°-54' West, 800 feet to a point on the West line of the South Prairie Road Addition to Meadowood, a recorded plat in said Section 1; thence North along the West line of the said plat to a point that is 35.8 feet North of the Southwest corner of Lot 630 of the said plat; thence South 89°-56'-34" West 58.43 feet; thence North 80°-03'-26" West 360 feet; thence South 09°-56'-34" West, 105 feet; thence North 80°-03'-26" West, 60 feet to a point of curve; thence on a curve to the right convex to the East having a radius of 15 feet and a long chord that bears South 54°-56'-34" West 21.21 feet; thence South 09°-56'-34" West, 60 feet; thence North 80°-03'-26" West 110 feet; thence South 09°-56'-34" West, 146.52 feet; thence South 41°-05'-35" West, 53.48 feet; thence South 44°-56'-34" West, 244 feet; thence South 32°-03'-41" West, 93.42 feet to a point of curve; thence on a curve to the right convex to the Northeast having a radius of 400 feet and a long chord that bears South 51°-29'-53" East, 89.74 feet; thence South 44°-56'-34" West, 60 feet to a point of curve; thence on a curve to the right convex to the East, having a radius of 15 feet and a long chord that bears South 0°-03'-26" East, 21.21 feet; thence South 45°-03'-26" East, 60 feet; thence South 44°-56'-34" West 71 feet; thence South 45°-03'-26" East, 125 feet; thence South 44°-56'-34" West 172 feet; thence South 12°-11'-09" East 209.04 feet; thence South 0°-19'-31" East 203 feet to a point 33 feet South of measured at right angles to the South line of the Northwest 1/4 of said Section 1; thence East on a line that is parallel to and 33 feet South of measured at right angles to the South line of the said Northwest 1/4 and the South line of the Northeast 1/4 of said Section 1 to a point that is 175 feet East of measured at right angles to the West line of the Northeast 1/4 of the Southeast 1/4 of said Section 1; thence North 373 feet on a line that is parallel to and 175 feet East of measured at right angles to the West line of the Northeast 1/4 of the said Southeast 1/4 and the West line of the Southeast 1/4 of the Northeast 1/4 of said Section 1; thence North 89°-10' East 675 feet; thence North 120 feet; thence North 15°-0' East, 120 feet; thence North 30°-0' East, 120 feet; thence North 68°-24' West 733.54 feet; thence North 21°-36' East 140 feet; thence North 68°-24' West 30 feet; thence South 21°-36' West 140 feet; thence South 89°-10' West 55 feet to a point that is 175 feet East of measured at right angles to the West line of the Southeast 1/4 of the Northeast 1/4 of said Section 1; thence North on a line that is parallel to and 175 feet East of measured at right angles to the last mentioned West line to the South line of the 8th Addition to Meadowood, a recorded plat in said Section 1; thence West on the last mentioned South line to the West line of the Southeast 1/4 of the said Northeast 1/4; thence South along the last mentioned West line to the point of beginning.
