

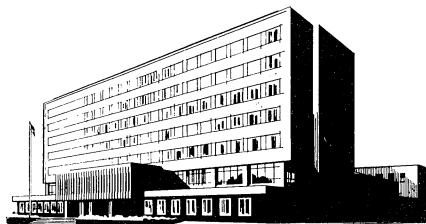

Part of the Northeast 1/4 of Section 28, Town 8 North, Range 10 East, Town of Burke, Dane County, Wisconsin, more fully described as follows:

Beginning at a point in the limits line of the City of Madison. Said point also being the Northeast corner of the Northwest 1/4 of the Northeast 1/4 of Section 28, Town 8 North, Range 10 East, Town of Burke, Dane County, Wisconsin; thence South 89°-03'-26" West, 480.0 feet along the limits line of the City of Madison and the North line of the Northeast 1/4 of said Section 28 to the Southeast corner of Lot 1, Block 3, Sandburg Heights, a recorded plat in the Southeast 1/4 of Section 21, Town 8 North, Range 10 East, City of Madison, Dane County, Wisconsin; thence Southerly 334 feet more or less along a line that is parallel to the East line of the Northwest 1/4 of the Northwest 1/4 of said Section 28 to the South line of the North 1/2 of the North 1/2 of the Northwest 1/4 of the Northeast 1/4 of said Section 28; thence Easterly 480 feet along the South line of the North 1/2 of the North 1/2 of the Northwest 1/4 of the Northeast 1/4 of said Section 28 to the East line of the Northwest 1/4 of the Northeast 1/4 of said Section 28; thence Northerly 334.2 feet along the East line of the Northwest 1/4 of the Northeast 1/4 of said Section 28 to the point of beginning.

Said territory and all persons and things coming within and residing within it shall and hereby are declared to be subject to all rules, regulations, and ordinances governing said Aldermanic District in the City of Madison."

2. The above described property is also annexed for all school purposes and is hereby made a part of the city school district and is subject to all laws and ordinances governing the same.
3. Pursuant to the provisions of Section 66.021 (7)(a) Wisconsin Statutes, and in accordance with the August 13, 1973, recommendation of the City Plan Commission of the City of Madison, Dane County, Wisconsin, the following described territory annexed by this ordinance is assigned a temporary zoning classification of R1 Residence.
