EAST WASHINGTON AVENUE - WEB AVENUE ANNEXATION

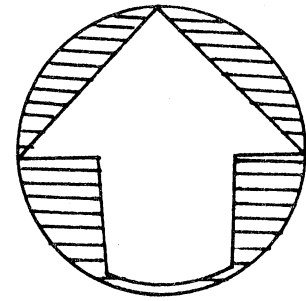

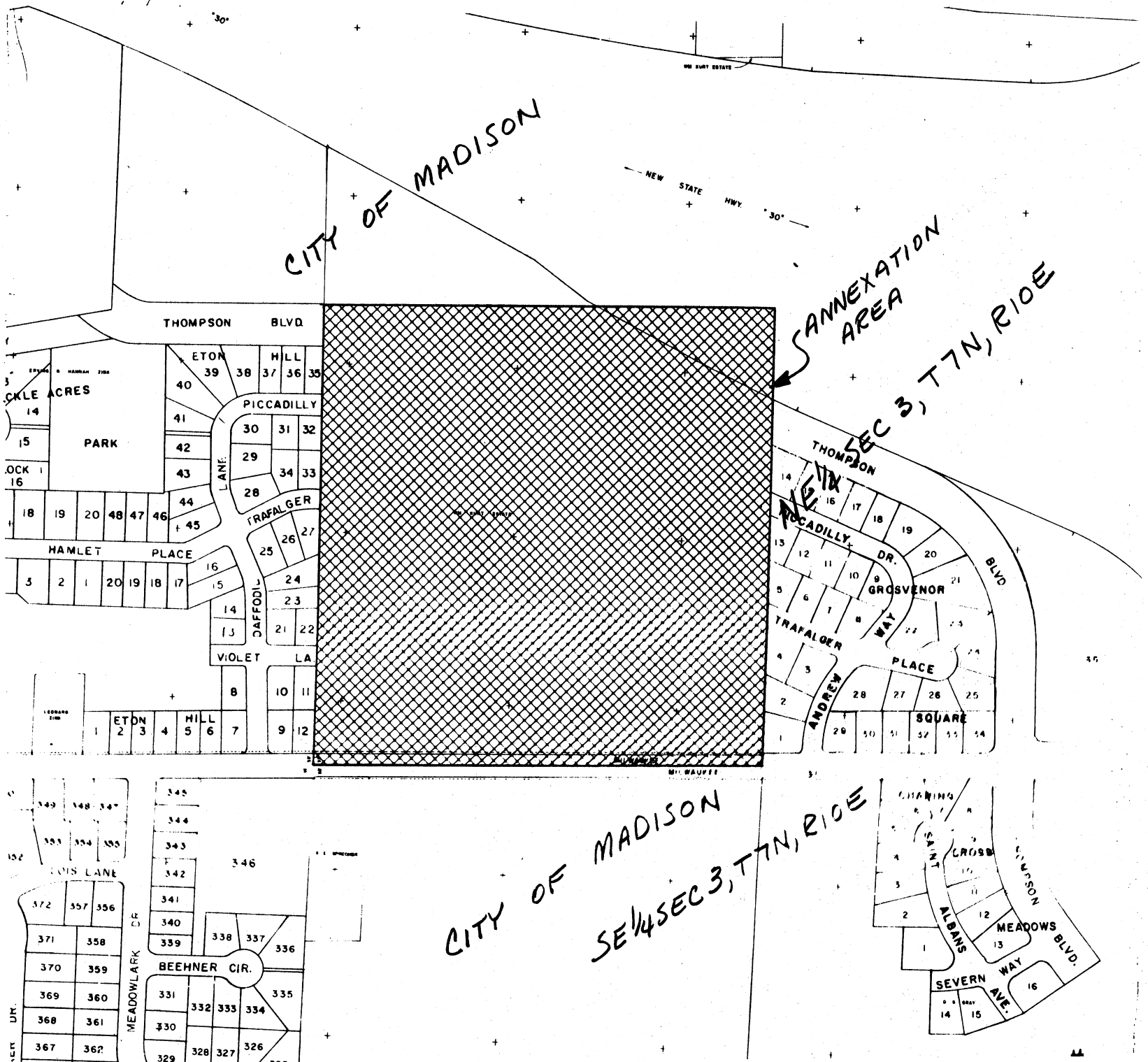

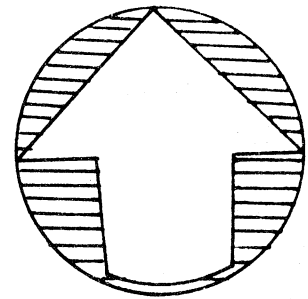


KURT ESTATE - MILWAUKEE STREET ANNEXATION



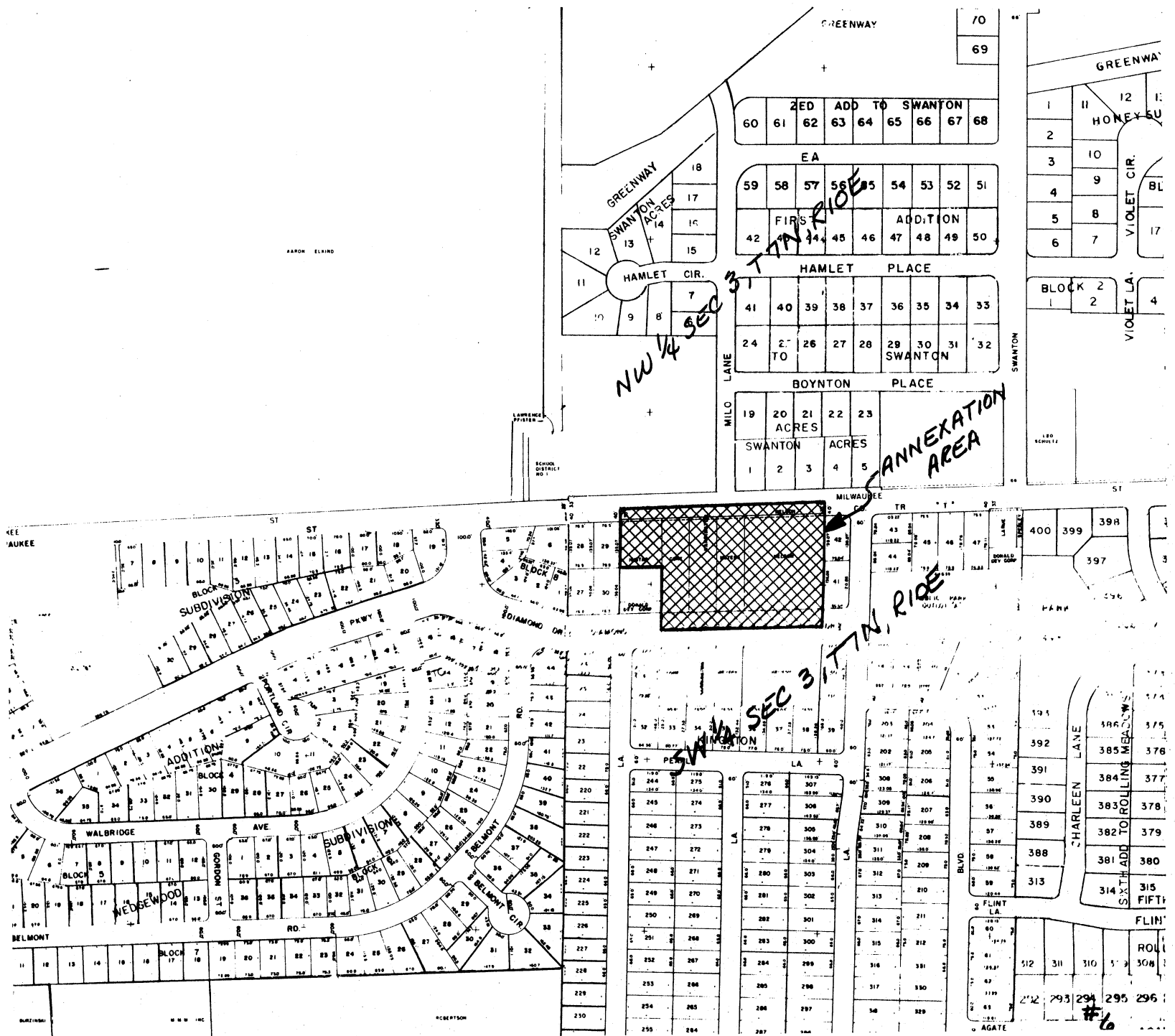

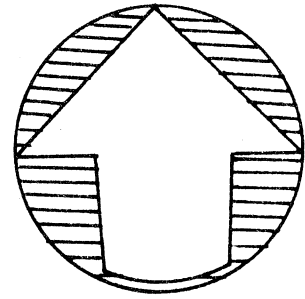

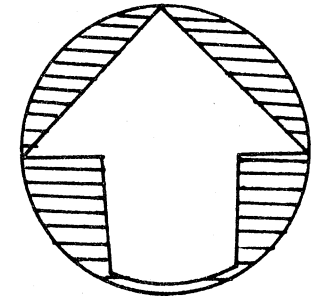

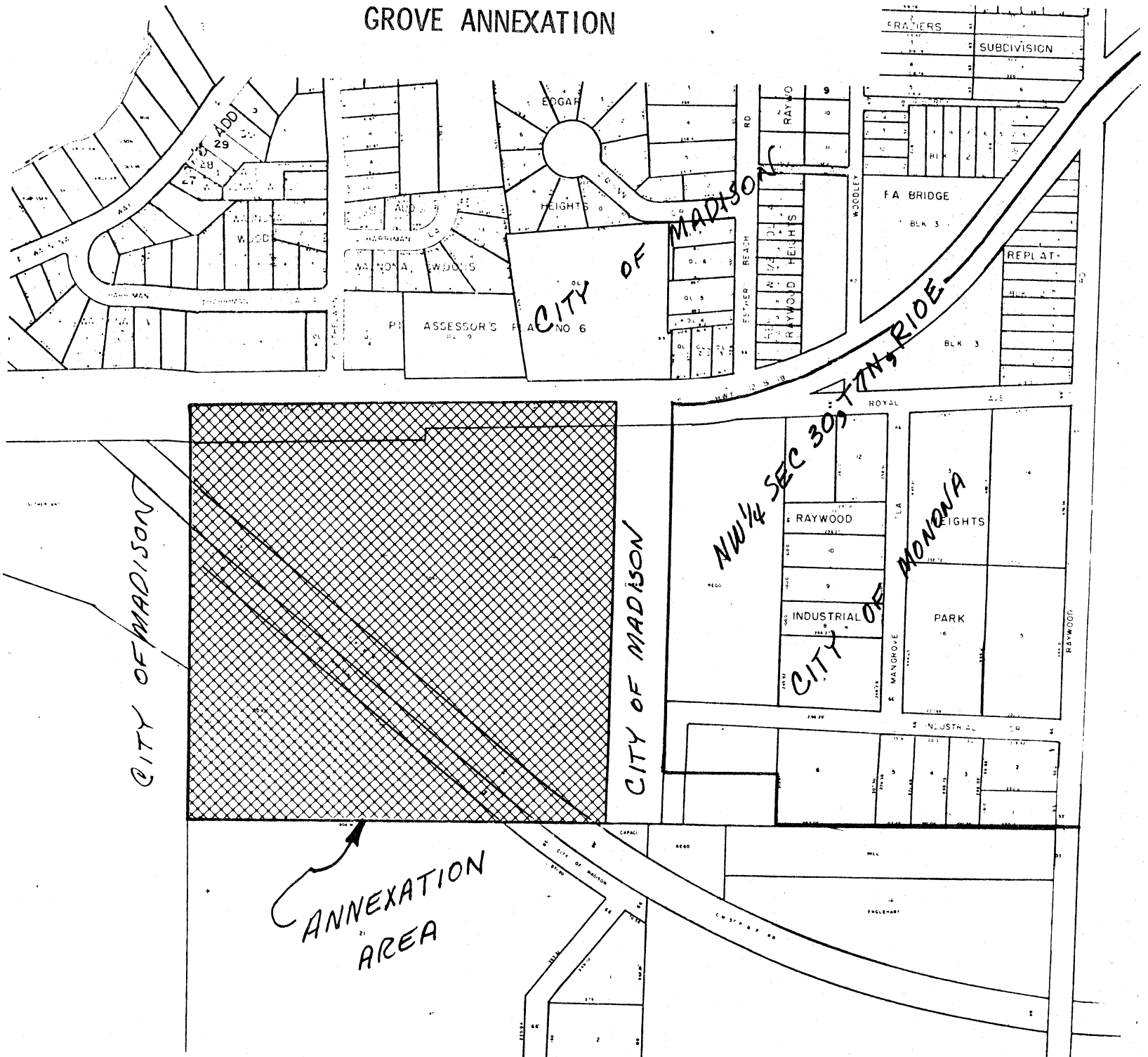

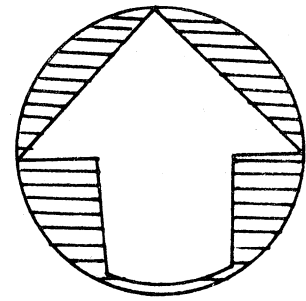

TOKI - WEST BROADWAY SECTION 30 BLOOMING GROVE ANNEXATION

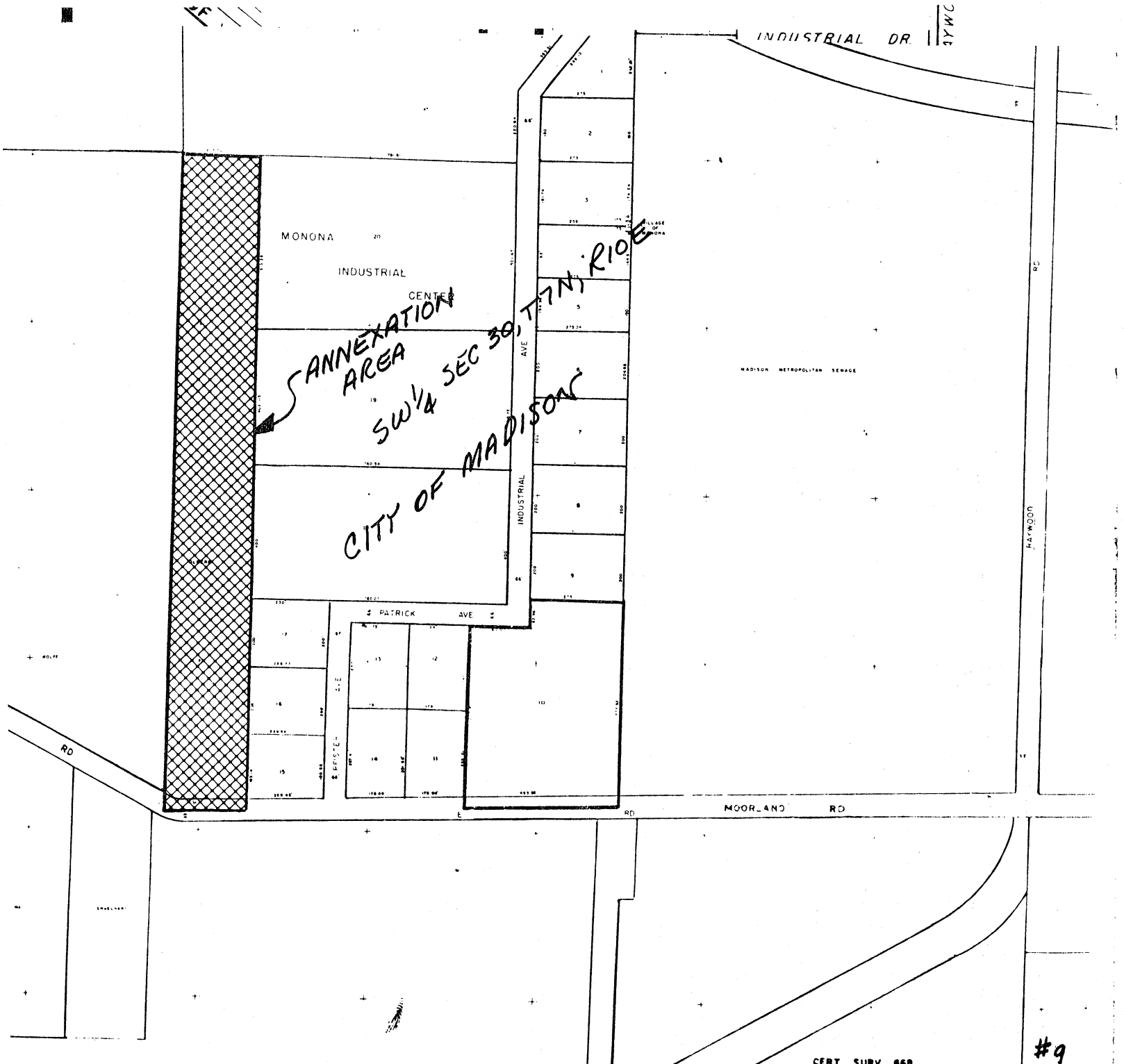

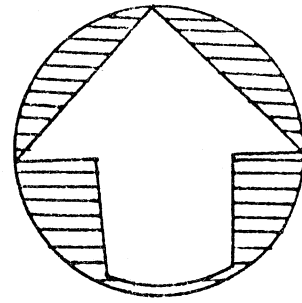
