

AN ORDINANCE

Creating Subsection 346 of Section 15.01 of the Madison General Ordinances entitled, "Aldermanic District Boundaries: and being part of the chapter entitled "Aldermanic Districts and Wards" annexing to the 3rd Aldermanic District the Buckeye Road Annexation.

Fiscal Note: No funds are necessary to complete this annexation.

SPONSOR(S): COMMON COUNCIL (Request of Planning Director)

An Ordinance to create Subsection 346 of Section 15.01 of the General Ordinances of the City of Madison entitled "Aldermanic District Boundaries" and being part of the chapter entitled "Aldermanic Districts and Wards".

WHEREAS, a petition with scale map attached has been presented to the Common Council requesting annexation of the below described territory to the City of Madison from the Town of Blooming Grove said petition having been signed by the owners of a majority of the land in area and assessed value within the territory and the majority of electors residing within the territory, which lies contiguous to the City of Madison; and

WHEREAS, investigation by the City of Madison discloses that as of this date the above representations are true, and the determination of the Head of the Planning Function, Department of Local Affairs and Development, State of Wisconsin, having been reviewed, the Common Council now accepts the petition as sufficient and determines that the said annexation proceeding meets the requirements of the Wisconsin Statutes;

NOW, THEREFORE, the Common Council of the City of Madison, Dane County, Wisconsin, do ordain as follows:

1. Subsection 346 of Section 15.01 of the General Ordinances of the City of Madison is created to read as follows:

"15.01 346 There is hereby annexed to the 3rd Aldermanic District, the City of Madison, Dane County, Wisconsin, the following described property:

BUCKEYE ROAD, I-90 ANNEXATION

Part of the Northwest  $\frac{1}{4}$  of Section 14, Town 7 North, Range 10 East, Town of Blooming Grove, Dane County, Wisconsin, more fully described as follows:


Commencing at a point in the limits line of the City of Madison, said point being in the South line of the Northwest  $\frac{1}{4}$  of said Section 14 and 210.59 feet East of the West  $\frac{1}{4}$  corner of said Section 14 measured along the South line of the Northwest  $\frac{1}{4}$  of said Section 14; thence along the limits line of the City of Madison North  $60^{\circ}21'$  West 292.70 feet; then continuing along the limits line of the City of Madison North  $18^{\circ}53'$  West 442.10 feet; thence continuing along the limits line of the City of Madison North 603.70 feet to the North line of the Southwest  $\frac{1}{4}$  of the Northwest of said Section 14; then Easterly along the North line of the Southwest  $\frac{1}{4}$  of the Northwest  $\frac{1}{4}$  of said Section 14 to its point of intersection with a line that is parallel to and 800 feet East of, measured at right angles to, the West line of the Northwest  $\frac{1}{4}$  of said Section 14 thence Northerly 1322 feet along a line that is parallel to and 800 feet East of, measured at right angles to, the West line of the Northwest  $\frac{1}{4}$  of said Section 14; then Easterly 760 feet more or less along the North line of the Northwest  $\frac{1}{4}$  of said Section 14 to its point of intersection with the Easterly right-of-way line of Interstate 90 as presently located; then Southerly along the said Easterly right-of-way line of Interstate 90 and its Southerly prolongations to the South line of the Northwest  $\frac{1}{4}$  of said Section 14; thence Westerly along the South line of the Northwest  $\frac{1}{4}$  of said Section 14 to the point of beginning.

"Said territory and all persons and things coming within and residing within it shall and hereby are declared to be subject to all rules, regulations, and ordinances governing said Aldermanic District in the City of Madison."

2. The above described property has already been annexed to the City school district and is already subject to all laws and ordinances governing the same.

3. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

4. This ordinance shall be in effect from and after its passage and publication and the same shall operate to annex and attach the territory described herein.
