

An Ordinance to create Subsection (357) of Section 15.01 of the General Ordinances of the City of Madison entitled "Aldermanic District Boundaries" and being part of the chapter entitled "Aldermanic Districts and Wards".

WHEREAS, a petition with scale map attached has been presented to the Common Council requesting annexation of the below described territory to the City of Madison from the Town of Middleton said petition having been signed by the owners of a majority of the land in area within the territory and no electors reside within the territory, and assessed value which lies contiguous to the City of Madison; and

WHEREAS, investigation by the City of Madison discloses that as of this date, the above representations are true, and the determination of the Head of the Planning Function, Department of Local Affairs and Development, State of Wisconsin, having been reviewed, the Common Council now accepts the petition as sufficient and determines that the said Annexation proceeding meets the requirements of the Wisconsin Statutes;

NOW, THEREFORE, the Common Council of the City of Madison, Dane County, Wisconsin, do ordain as follows:

1. Subsection (357) of Section 15.01 of the General Ordinances of the City of Madison is created to read as follows:

"15.01(357) - There is hereby annexed to the 1st aldermanic district of the City of Madison, Dane County, Wisconsin, the following described property:

Part of the Southwest 1/4 of the Southeast 1/4 of Section 25, Town 7, North Range 8 East, Town of Middleton, Dane County, Wisconsin, more fully described as follows:

Beginning at a point in the limits line of the City of Madison, said point being in the West Line of the Southeast 1/4 of said Section 25 and 400 feet North of the South 1/4 corner of said Section 25; thence, Northerly along the West Line of the Southeast 1/4 125 feet; thence, Easterly along a line parallel to and 525 feet North of, the South Line of the Southeast 1/4 of said Section 25 - 500 feet; thence, Southerly 125 feet more or less to a point 400 feet North of the South Line of said Southeast 1/4 of Section 25 and 500 feet East of the West Line of said Southeast 1/4; thence, Easterly 500 feet along a line parallel to and 400 feet North of said South Line of the Southeast 1/4 to the point of beginning.

Said territory and all persons and things coming within and residing within it shall and hereby are declared to be subject to all rules, regulations, and ordinances governing said Aldermanic District in the City of Madison."

2. The Above described property is also annexed for all school purposes and is hereby made a part of the City school district and is subject to all laws and ordinances governing the same.
3. Pursuant to the provisions of Section 66.021(7)(a) Wisconsin Statutes, and in accordance with the July 21, 1980, recommendation of the City Plan Commission of the City of Madison, Dane County, Wisconsin, the following described territory annexed by this ordinance is assigned a temporary zoning classification of M1.

Part of the Southwest 1/4 of the Southeast 1/4 of Section 25, Town 7, North Range 8 East, Town of Middleton, Dane County, Wisconsin, more fully described as follows:

Beginning at a point in the limits line of the City of Madison, said point being in the West Line of the Southeast 1/4 of said Section 25 and 400 feet North of the South 1/4 corner of said Section 25; thence, Northerly along the West Line of the Southeast 1/4 - 125 feet; thence, Easterly along a line parallel to and 525 feet North of, the South Line of the Southeast 1/4 of said Section 25 - 500 feet; thence, Southerly 125 feet more or less to a point 400 feet North of the South Line of said Southeast 1/4 of Section 25 and 500 feet East of the West Line of said Southeast 1/4; thence, Easterly 500 feet along a line parallel to and 400 feet North of said South Line of the Southeast 1/4 to the point of beginning.

4. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given without the invalid or unconstitutional provision or application.
