A CHARTER ORDINANCE to amend Section 2.13 (A) of the Code of Ordinances of the City of La Crosse pertaining to Membership on the Board of Public Works.

THE COMMON COUNCIL OF THE CITY OF LA CROSSE DO ORDAIN AS FOLLOWS:

SECTION I: Subsection (A) of Section 2.13 of the Code of Ordinances of the City of La Crosse is hereby amended to be numbered, entitled and read as follows:

2.13 (A) MEMBERSHIP

VEL PHILLIPS SECRETARY OF STATE The Mayor, Director of Finance and Purchase, City Attorney, City Engineer, Director of Public Works, and one Alderman shall constitute the Board of Public Works. The Aldermanic member of said Board shall be elected by the Council on the 3rd Tuesday in April in the odd numbered years; provided however the first Aldermanic member shall be elected upon the adoption of this ordinance.

SECTION II: This Ordinance shall take effect and be in force 60 days after its passage and publication unless within said period a referendum petition shall be filed as proveded by law in which event this Ordinance shall not take effect until submitted to a referendum vote and approved by a majority of the electors voting thereon.
