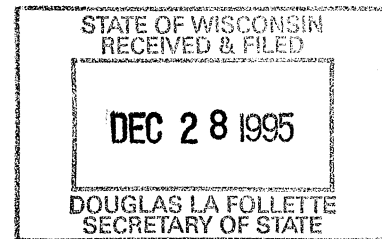

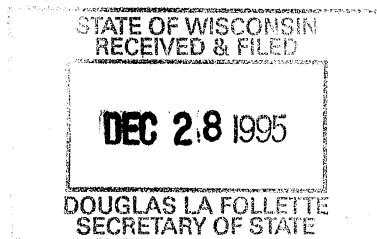

AN ORDINANCE to annex a parcel of land from the Town of Shelby to the City of La Crosse.  
(Kwik Trip Property, 4605 Mormon Coulee Road)

THE COMMON COUNCIL of the City of La Crosse do ordain as follows:

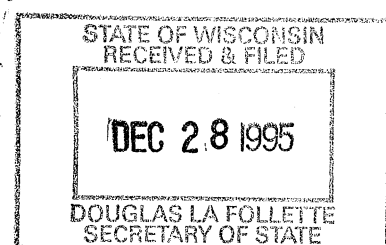
SECTION I: Proper petition having been presented to the Common Council of the City of La Crosse praying for annexation of the following territory, to-wit:

A parcel of land located in the NE 1/4 of the NE 1/4 of Section 21, T15N, R7W, Town of Shelby, La Crosse County, Wisconsin, more fully described as follows:

Commencing at the Northeast corner of said NE 1/4 of the NE 1/4; thence South 89° 59' West 368.69 feet; thence South 0° 01' East 350.45 feet to the point of beginning of this description; thence South 5° 45' 24" East 159.91 feet; thence South 67° 21' West 195.86 feet to the Easterly right-of-way line of Mormon Coulee Road; thence North 27° 49' 05" West along said Easterly right-of-way line 26.58 feet; thence continuing along said Easterly right-of-way line along the arc of a 4,623.66 foot radius curve, concave to the Southwest, the chord of which bears North 29° 43' West and measures 245.02 feet; thence South 89° 39' East 298.55 feet to the point of beginning.

Parcel contains approximately 1.14 acres.

to the City of La Crosse, Wisconsin, it is hereby ordained that the above described property be, and the same is hereby annexed to the City of La Crosse, Wisconsin, from the Town of Shelby, La Crosse County, Wisconsin, and it is further ordered that Sec. 1.01 of the Code of Ordinances of the City of La Crosse entitled "City Boundaries" is hereby amended to include the



above described property within the corporate limits of the City of La Crosse, Wisconsin.

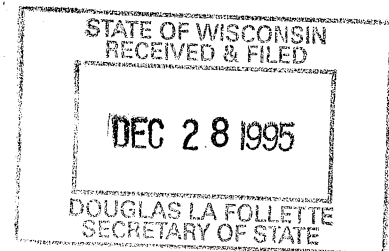

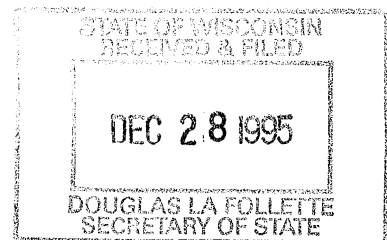

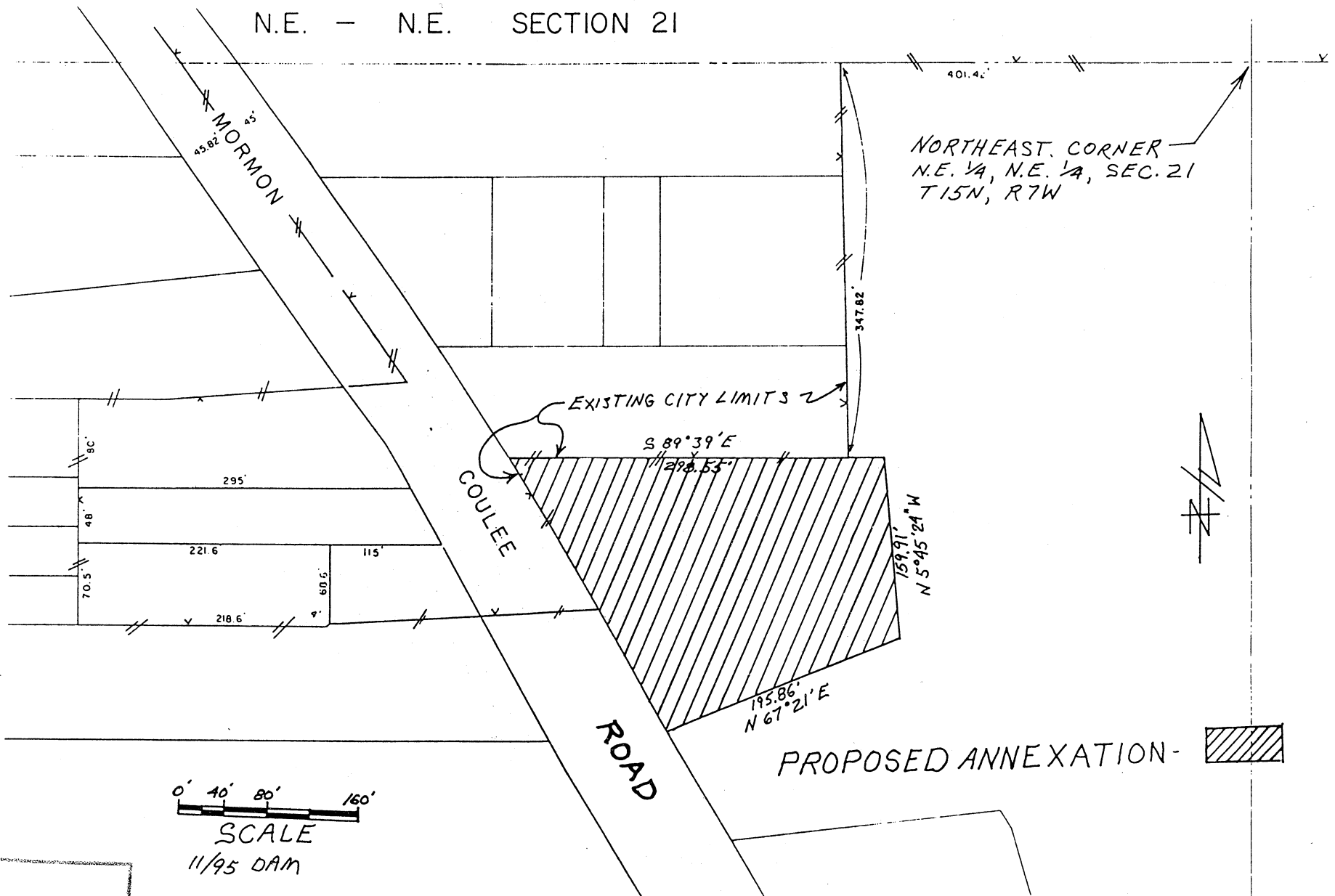
