ORDINANCE NO. 1363



**ORDINANCE AMENDING DESCRIPTION ANNEXING LAND TO
THE TOWN OF BUCHANAN
TO THE CITY OF KAUKAUNA (ANDERSON)**

WHEREAS, a Petition for Direct Annexation signed by all owners of land and all electors residing in the area within such territory, has been filed with the Clerk/Treasurer of the City of Kaukauna and the Clerk of the Town of Buchanan, together with a scale map and a full description of the property to be annexed showing the boundaries of such territory and the relation of the territory to the municipality to which annexation is requested; and,

WHEREAS, notice of the proposed annexation was served upon the State of Wisconsin Department of Administration, and said Department has determined that the proposed annexation is not against the public interest; and,

WHEREAS, there has been due compliance with all of the requirements of Section 66.021 of the Wisconsin State Statutes; and,

WHEREAS, the maps of the parcel to be annexed were accurate, but the legal description of the property as contained in the petition and the original annexation ordinance adopted February 3rd, 1998, was inaccurate due to the change in the city limits line of August 9, 1968.

NOW, THEREFORE, the Common Council of the City of Kaukauna do ordain as follows:

That the particular property hereinafter described pursuant to the Petition filed with the Clerk/Treasurer of the City of Kaukauna be, and the same is, hereby annexed to the City of Kaukauna, and the same is hereby detached, by operation of law, from the Town of Buchanan, Outagamie County, Wisconsin. That the territory so annexed is known and described as follows:

South six acres of north ten acres of that part of Government Lot 4, lying south of Kaukauna City Limits, as existed on July 31, 1968, Section 21, Township 21 North, Range 18 East, Town of Buchanan, Outagamie County, Wisconsin.

This ordinance shall be in full force and effect from and after its adoption.
