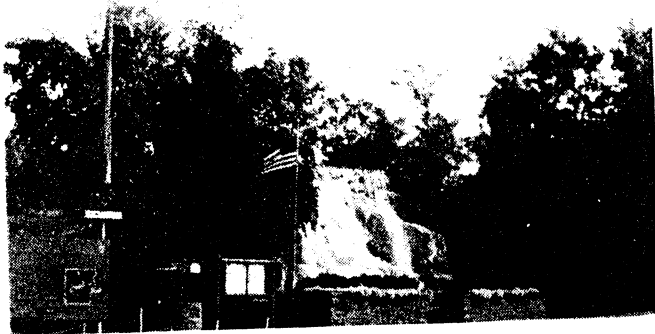

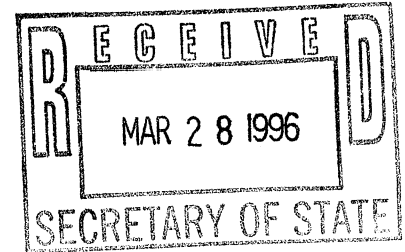

Montello's Granite Falls



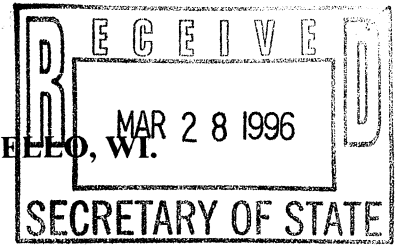

ORDINANCE NO. 1996

AN ORDINANCE ANNEXING PROPERTY TO THE CITY OF MONTELLO, WI.

WHEREAS, the City of Montello has received a Petition for Annexation in compliance with Chapter 66.021 of the Wisconsin Statutes and

WHEREAS, no objection has been received from the Town of Montello concerning said annexation and

WHEREAS, said annexation is a parcel attached to a recently annexed parcel,

THEREFORE the City of Montello, pursuant to Chapter 66.021(12) of the Wisconsin Statutes, does hereby annex to said City and cause the official map thereof to be amended, the following:

A part of Lot 1, Certified Survey Map No. 1523, located in Section 9, Township 15 North, Range 10 East, Town of Montello, Marquette County, Wisconsin, described as follows:

Commencing at the Northwest corner of said Lot 1; thence S02 48' 25"E, 218.98 feet to the point of beginning; thence continuing S02 48' 25"E, 150.00 feet to the Southwest corner of said Lot 1; thence along the Southern boundary of Lot 1 and the Northerly R/W line of S.T.H. "23", 80.00 feet; thence N02 48' 25"W, 150.00 feet; thence S88 29' 08"W, 80.00 feet to the point of beginning.

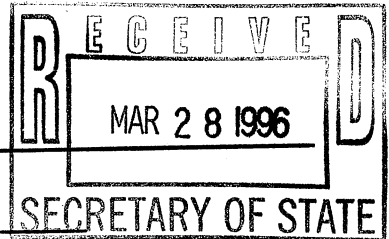

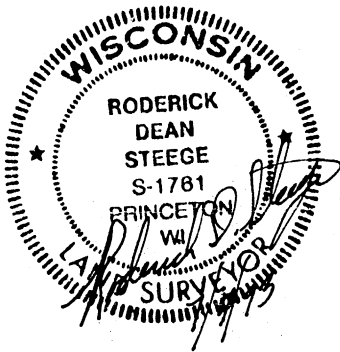

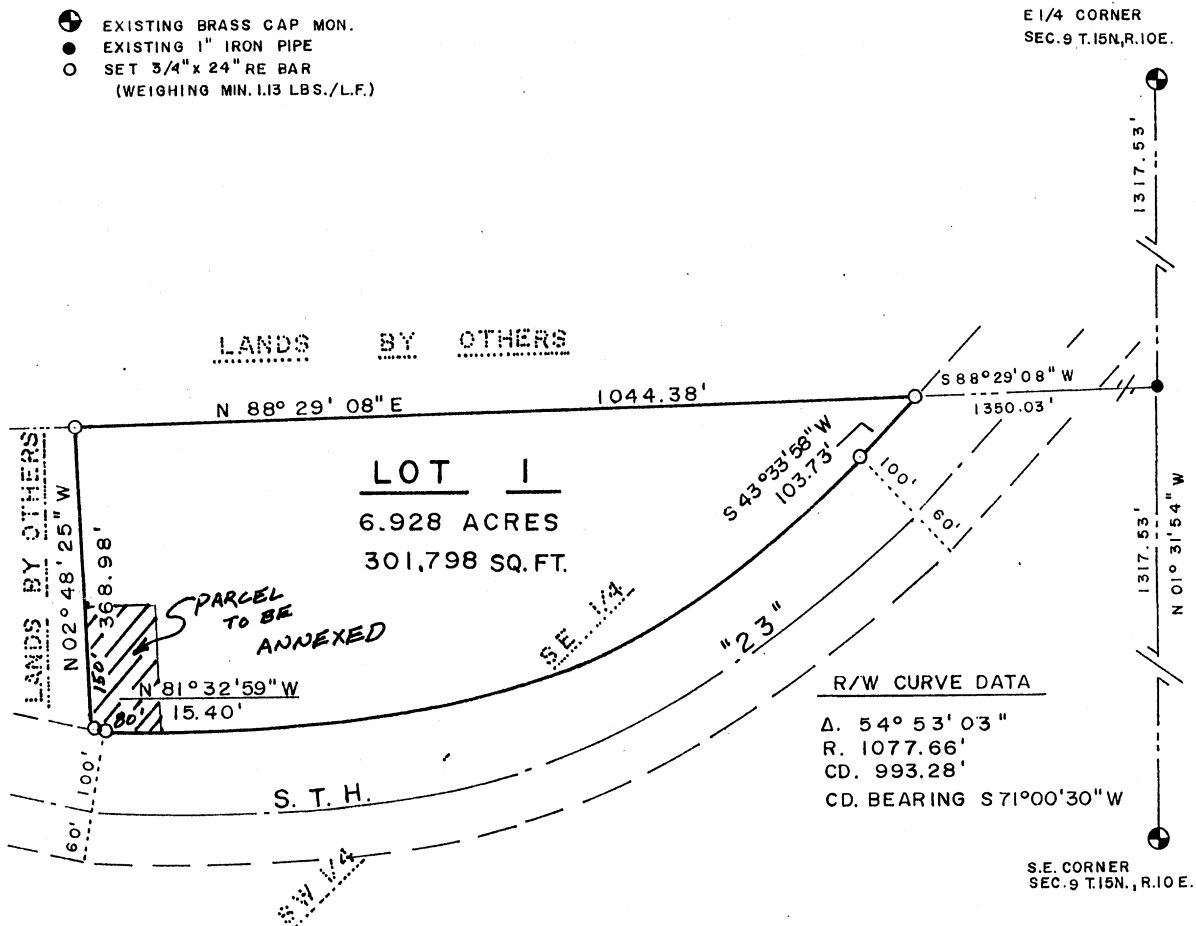

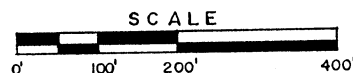

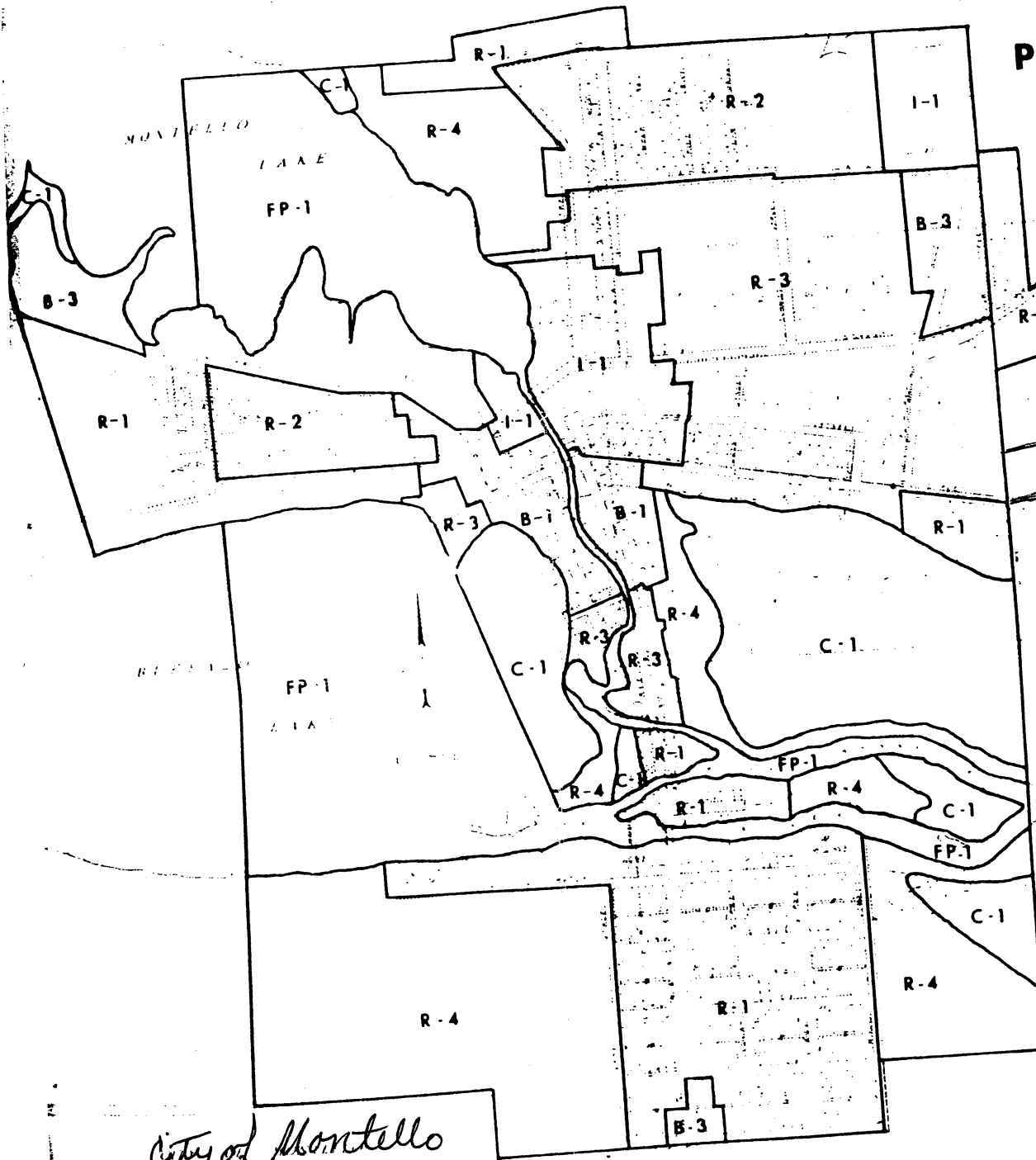
