Laughlin & W. J. Brown, residents and tax payers of the territory proposed for incorporation and Guernsey and Lehr appearing as Attorneys for the said petitioners and no one appearing or making or filing any objections to the granting of said petition;

And due proof having been made and filed as required by law from which it appears to the satisfaction of the Court:

lst. That the said proposed territory on the 25th day of Aug. 1898 contained the requisite number of inhabitants as required by law.

2nd. That an accurate survey and map of said proposed territory was caused to be made and with a correct census of the residents of said proposed territory were left for examination and inspection at a public place for a period of five weeks and that all the requirements of the Statutes have been complied with.

That the lands embraced in said proposed territory ought justly to be included in the proposed Village. That the interests of the inhabitants will be promoted by such incorporation.

That said territory which ought to be included contained at the time such census was taken the population in number and in

proportion to the quantity of land required by law.
