ORDINANCE NO. 12

AN ORDINANCE RELATING TO ANNEXATION OF TERRITORY ADJACENT TO THE CITY OF LODI, COLUMBIA COUNTY, WISCONSIN

A petition for direct annexation having been filed by all of the electors and landowners of certain territory, hereinafter described, located adjacent and contiguous to the City of Lodi;

The Common Council of the City of Lodi, Wisconsin do hereby ordain as follows:

(1) That the following described property located in the Town of Lodi, Columbia County, Wisconsin, be and the same is hereby annexed to the City of Lodi, to-wit:

A parcel of land in Section 22, T 10 N, R 8 E, which is bounded by a line described as follows:

Commencing at the southwest corner of Section 22; thence S 89 degrees 45' E, 1400 feet along the south line of Section 22 to the centerline of State Trunk Highway #113 and the point of beginning; thence N 89 degrees 45' W, 450 feet along the south line of Section 22 to the northeast line of Chicago & Northwestern Railroad lands; thence N 42 degrees 48' W, 434.8 feet along the northeast line of Chicago & Northwestern Railroad lands; thence N 54 degrees 31' E, 422.2 feet to the centerline of State Trunk Highway #113; thence S 35 degrees 29' E, 538.2 feet along the centerline of State Trunk Highway #113 to a point which is 165 feet northwest of the intersection of the centerline of said highway and the south line of Section 22; thence N 63 degrees 30' E, 128 feet; thence S 82 degrees 45' E, 264 feet; thence S 40 degrees 30' E, 198 feet to said south line of Section 22; thence West 408.5 feet along said south line of Section 22 to the point of beginning.

(2) That said property be annexed to Ward No. 1 of the City of Lodi.

(3) That the said property annexed shall be temporarily classified for zoning purposes as follows:

(a) That portion of said property annexed which is owned by ALKAR ENGINEERING CORPORATION shall be temporarily classified as I-1 Industrial Parks.

(b) The remainder of said property annexed shall be temporarily classified as R-1 Single Family.

This ordinance shall take effect upon passage of publication.

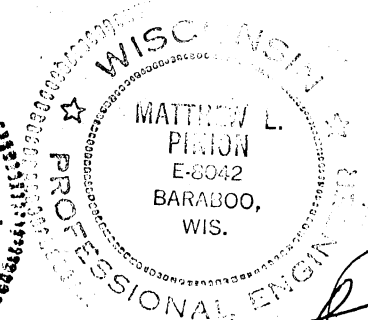
