Commencing at the NE corner of the SE_4 of NW_4 of Section 25, T20N, R20E in Calumet County, Wisconsin thence in a westerly direction along the north boundary line of said SE¹/₄ of NW¹/₄ 300 ft. thence north 626 ft. thence west to the west boundary of the NE1 of NW1 of Section 25, thence north along said line to the NE corner of the SW14 of SW14 of Section 24, thence west along the north boundary lines of the SW_4 of SW_4 of Section 24 and the SE¹/₄ of the SE¹/₄ of Section 23, thence approximately 90 more feet west along the north line of the SW14 of SE14 of Section 23, thence north 1320 ft. to the north line of the NW14 of SE14 of Section 23, thence west 1130 ft. to'the NW corner of said NW14 of SE14 of Section 23, thence south 1320 ft. to the SW corner of the NW14 of SE14 of Section 23, thence west along the 1/16th section line approximately 2640 ft. to the NW corner of the SW1 of SW1 of Section 23, thence north approximately 1320 ft. to the east west 1/4 line of Section 22, thence west 2035.47 ft, thence south to the south line of U.
