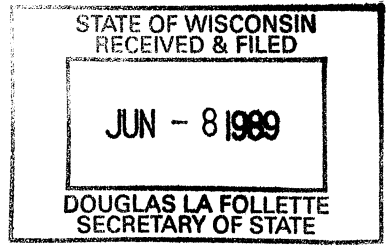

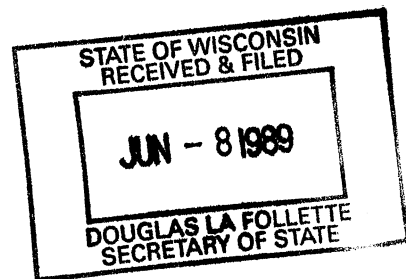

THE COMMON COUNCIL OF THE CITY OF GILLETT, WISCONSIN, DO  
ORDAIN AS FOLLOWS:

That pursuant to Section 66.025, Wisconsin Statutes, the  
following described property is hereby annexed to the City of  
Gillett, Wisconsin, Oconto County, Wisconsin:

Part of the Northwest Quarter (1/4) of the Northeast  
Quarter (1/4), Section 28, Township 28 North, Range 18  
East, County of Oconto, State of Wisconsin, described as  
follows:

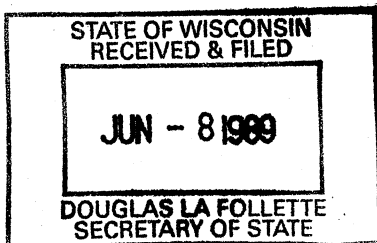
Beginning at the North 1/4 post of Section 28, thence  
south on the said 1/4 line to the center of the  
public highway, thence Northeasterly along the center  
of the said highway to the section line between  
Sections 21 and 28, thence West on the said section  
line to the place of beginning.

Said property is contiguous to the City of Gillett.

BE IT FURTHER RESOLVED, that the above described property  
is owned by the City of Gillett, said property having been  
purchased by the city on February 7, 1989. That previous to  
the purchase of said property, said property was located within  
the Town of Gillett, Oconto County, Wisconsin.

BE IT FURTHER RESOLVED, that the Clerk/Treasurer is hereby  
authorized and directed to file five (5) certified copies of  
this ordinance along with five (5) copies of a plat showing the  
boundaries of the territory attached in the Office of the  
Secretary of State. Upon the filing of said copies with the  
Secretary of State's office, the above described property shall  
be deemed to be attached to the City of Gillett, Wisconsin.

This Ordinance shall take effect upon passage and  
publication by law.

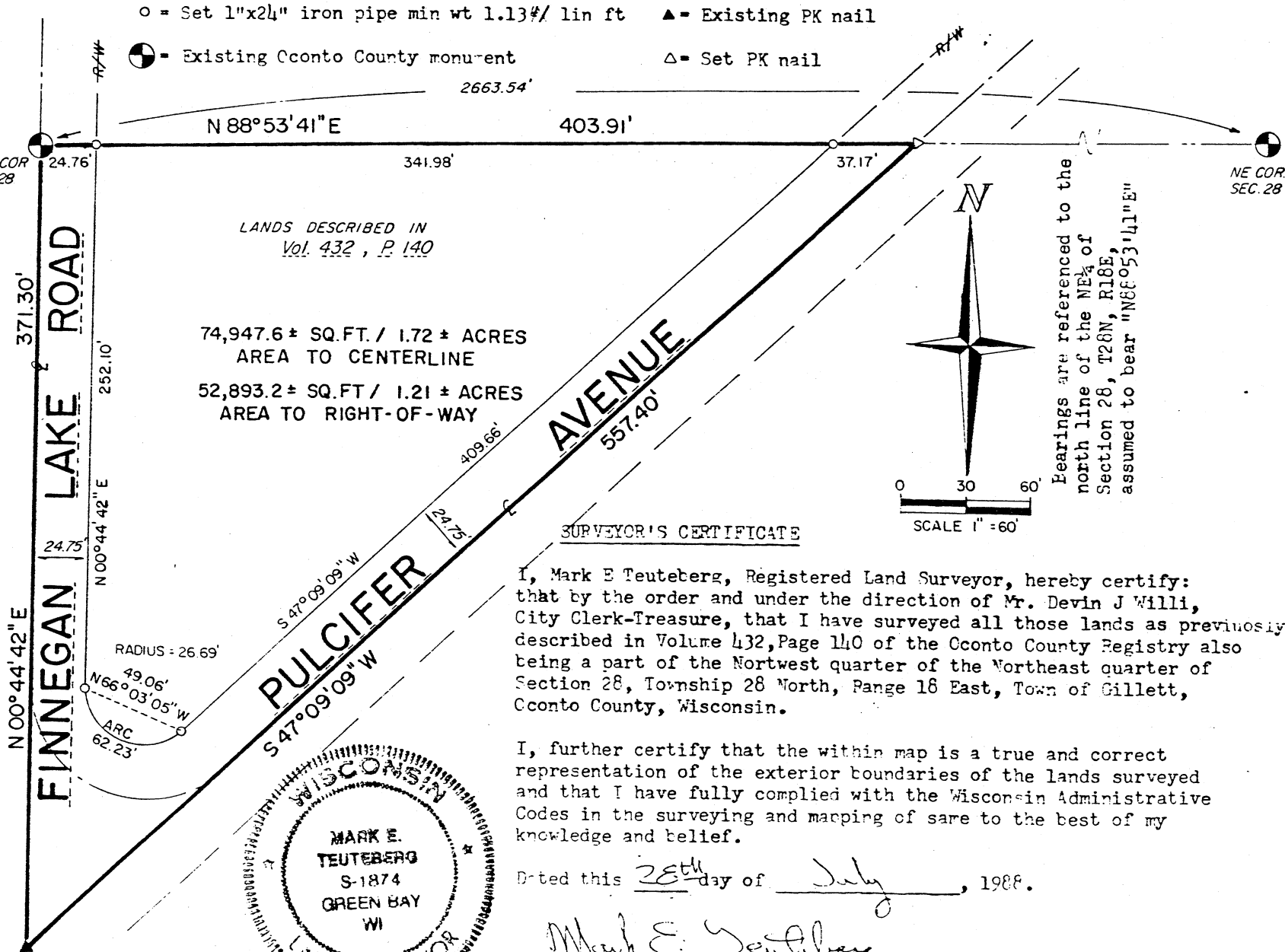

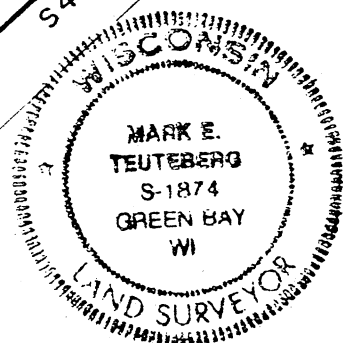
