

AN ORDINANCE ANNEXING TERRITORY TO THE CITY  
OF SCHOFIELD, MARATHON COUNTY, WISCONSIN  
(Gaffney)

WHEREAS, A Petition for Annexation by Unanimous Consent has been duly filed, signed by the electors and the owners of the real property in the following described territory requesting annexation to the City of Schofield; and,

WHEREAS, Said Petition has been duly referred to the Plan Commission of the City of Schofield and to the Department of Local Affairs and Development of the State of Wisconsin and recommendations having been made to the Common Council by both bodies;

NOW, THEREFORE, The Common Council of the City of Schofield, Marathon County, Wisconsin, do ordain as follows:

Section 1: Territories Annexed. In accordance with Section 66.021 of the Wisconsin Statutes and said Petition for Annexation by Unanimous Consent filed with the Clerk of the City of Schofield on the 22nd day of August, 1988 signed by the electors residing in, and the owners of the real property in said territory; the following described territory heretofore lying in the Town of Weston, Marathon County, Wisconsin, is annexed to the City of Schofield, Marathon County, Wisconsin:

Parcel 1: Parcel one (1) of Certified Survey Map No. 3509 recorded in the office of the Register of Deeds for Marathon County, Wisconsin, in Volume 13 of Certified Survey Maps on page 104; being a part of Lots one (1), two (2) and the South twenty (20) feet of Lot three (3), all in Block four (4) of Mylrea's Acre Lots, in the Town of Weston, Marathon County, Wisconsin.

Parcel 2: Lot three (3); excepting the South twenty (20) feet thereof; and Lot four (4), all Block four (4) of Mylrea's Acre Lots, in the Town of Weston, Marathon County, Wisconsin; excepting that part thereof conveyed by Deed recorded in the office of the Register of Deeds for Marathon County, Wisconsin, in Volume 281 of Deeds on page 515.

Section 2: From and after the date of adoption of this Ordinance, the territories hereinbefore described shall be a part of the said City of Schofield and for any and all purposes provided by law and all persons residing or coming into or within said territory shall be subject to all ordinances, rates and regulations governing said City of Schofield.

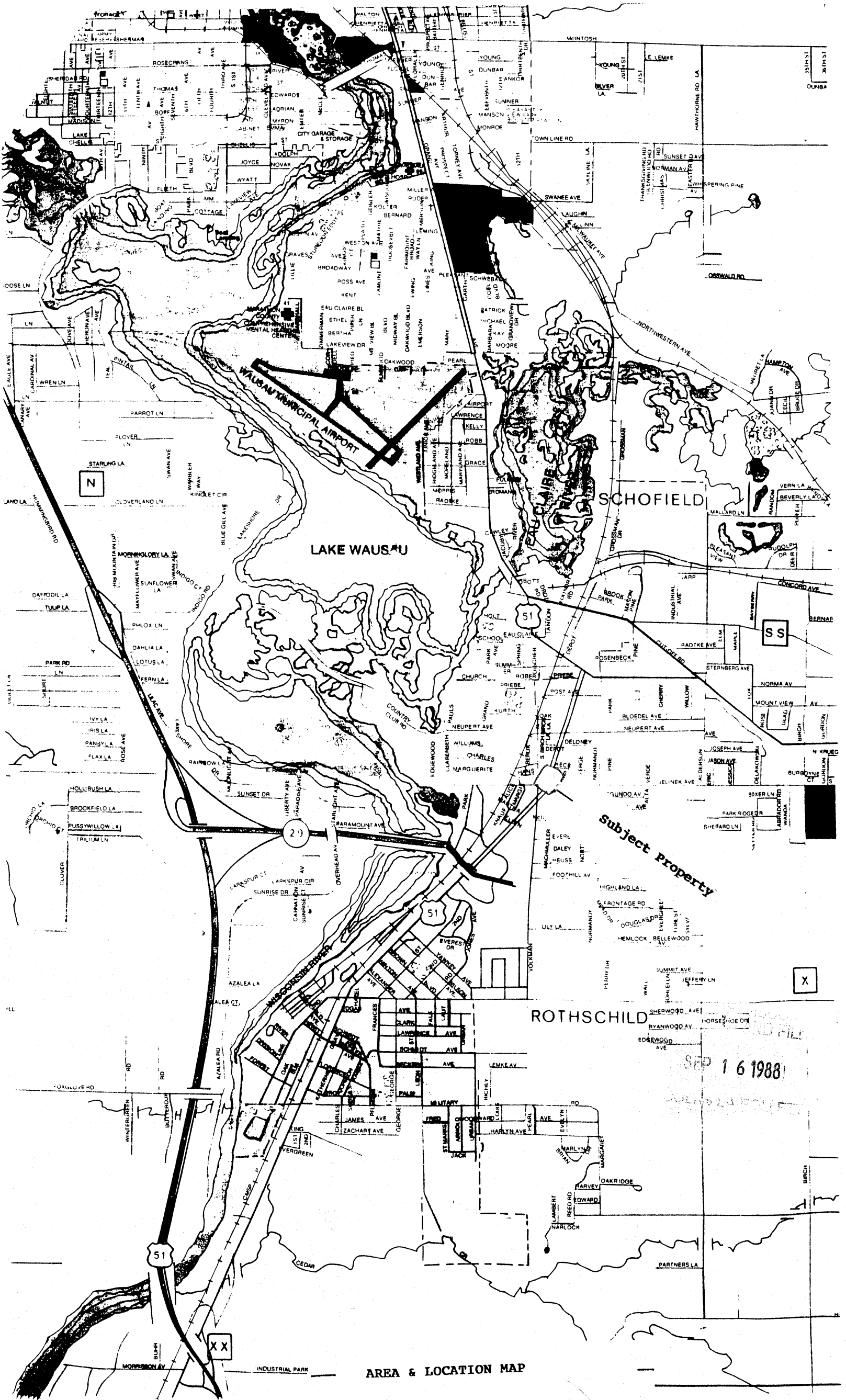
