



CERTIFICATE OF ANNEXATION

I, Mary Pohle, City Clerk of the City of New Lisbon, County of Juneau, State of Wisconsin, DO HEREBY CERTIFY that the following described territory was detached from the Town of Lisbon, County of Juneau, and was annexed to the said City of New Lisbon pursuant to Section 66.021(12) of the Wisconsin Statutes, by an Ordinance adopted by the Common Council at a regular meeting held April 5, 1966:

Commencing at a point on the west line of Section Nine (9), Township Sixteen (16) North, Range Three(3) East, 2008.3 feet south of the northwest corner thereof, at a point where the eastbound reference line of Interstate Highway 90 and 94 intersects the said west line of Section 9; extending thence south along the said west line to its intersection with the southwest right of way line of the said Interstate Highway 90 and 94; thence S 48° 38' E along the said southeast line to a line bearing S 35° 03' E; thence S 35° 03' E a distance of 637.77 feet to a line bearing S 46° 29' W; thence S 46° 29' W along the northwest line of present traveled S.T.H. 80 a distance of 470.95 feet; thence westerly along a curve, 80 feet northerly of and parallel to said S.T.H. 80 to the west line of said Section 9; thence south along the said west line to its intersection with the south line of said S.T.H. 80; thence east along the said south line to its intersection with a line bearing N 66° 38' E; thence N 66° 38' E a distance of 1133.53 feet to the intersection with a line bearing S 86° 29' E; thence S 86° 29' E a distance of 819.42 feet to the southwest right of way line of present traveled Interstate Highway 90 and 94; thence S 54° 38' E to the south 1/16 line of said Section 9; thence easterly along the said 1/16 line to the northeast line of said traveled Interstate Highway 90 and 94; thence N 54° 38' W to a curve; thence northwesterly along the said curve to a line bearing N 20° 09' W; thence N 20° 09' W a distance of 490.29 feet to a line bearing N 56° 24' E along Germantown Road; thence N 56° 24' E a distance of 487.18 feet; thence northwesterly at right angles across said Germantown Road 66 feet; thence S 65° 06' W a distance of 487.18 feet; thence N 49° 37' W to the easterly right of way line of present traveled S.T.H. 80; thence northerly along the said east right of way of S.T.H. 80 to the north 1/16 line of said Section 9; thence westerly 140 feet along the said 1/16 line to the westerly right of way line of said S.T.H. 80; thence southerly along the west line of S.T.H. 80 to a line bearing S 47° 08' W; thence S 47° 08' W a distance of 424 feet to a line bearing 79° 10' W; thence N 79° 10' W a distance of 630.85 feet; thence N 54° 38' W along the northeasterly line of present traveled Interstate Highway 90 and 94 to the west line of said Section 9; thence southerly along the said west line to the place of beginning .

Dear Sir:

On April 5, 1966 an ordinance was passed annexing the Interstate 90 and 94, and STH 80 lying within the boundaries of that portion of the City which was annexed in 1965. Shortly after, a certificate and plats were sent to your office. However, the State Highway Commission informs me that they never received their copies and cannot certify aid on the streets in that portion of the City. Assuming that the certificate and plats were not received in your office, I am enclosing four plats of the last annexation and four plats which the Highway Department desires, showing the complete area annexed in 1965 and 1966, and the certificate of annexation.

Also enclosed are four(4) certificates reporting the corporate limits of the City after last alteration.

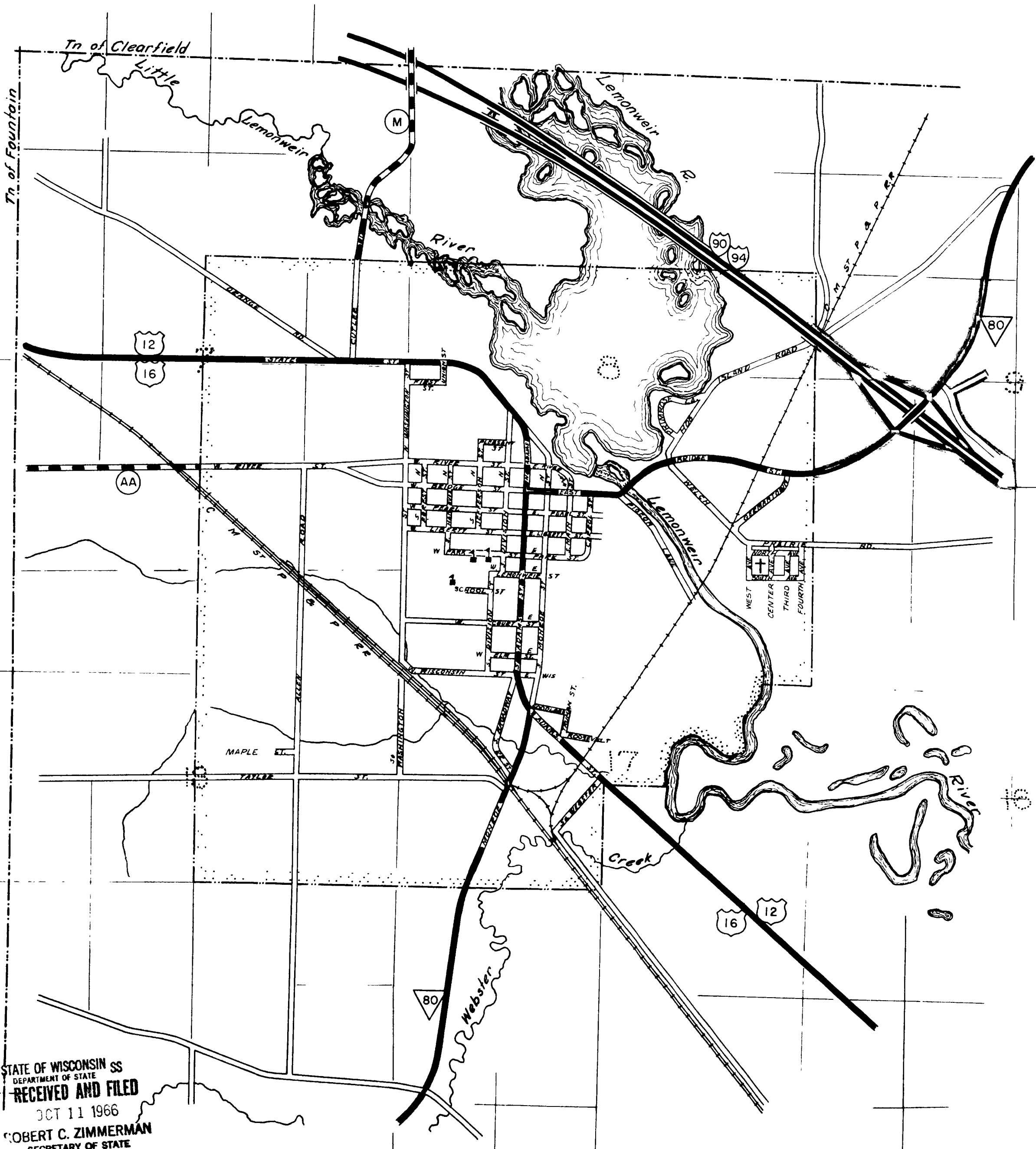
