the present limits of said City as of 1 December 1986.



All lying within T16N, R3E, Juneau County, Wisconsin:

Beginning at the northeast corner of the SE Quarter of the NE Quarter of Section 8;

Thence West along the center line of the NE Quarter of Section 8 to the southeast corner of the NW Quarter of the NE Quarter of Section 8;

Thence North to the northeast corner of the NW Quarter of the NE Quarter of Section 8;

Thence North to the northeast corner of the West one-half of the East one-half of Section 5;

Thence West to the northwest corner of the East one-half of the East one-half of the West one-half of Section 5;

Thence South to the northwest corner of the East one-half of the NE Quarter of the NW Quarter of Section 8;

Thence South to the southwest corner of the East one-half of the NE Quarter of the NW Quarter of Section 8;

Thence West along the centerline of the NW Quarter of Section 8 and the NE Quarter of Section 7;

Thence South along the North-South Quarter lines of Section 7 and Section 18 to the Southwest corner of the NW Quarter of the SE Quarter of Section 18;

Thence East along the center line of the SE Quarter of Section 18 and the SW Quarter of Section 17 to the southeast corner of the NE Quarter of the SW Quarter of Section 17;

Thence North to the northwest corner of the NW Quarter of the SE Quarter of Section 17;

Thence East to the Lemonweir River;

Thence Southeasterly along the centerline of the Lemonweir River to the centerline of Webster Creek;

Thence Southwesterly along the centerline of Webster Creek to the centerline of U.S.H. "12 and 16";

Thence Southeasterly 890 feet more or less, along the centerline of U.S.H. "12 and 16";

Thence N 36°01'E, 349 feet;

Thence S 49°17'30" E, 212.35 feet to the east line of the SE Quarter of Section 17;

Thence N 01°56'30" E, 776.85 feet along the east line of the SE Quarter of Section 17;

Thence N 88°03'30" W, 150.00 feet;

Thence N 82°57'30" W, 148.00 feet;

Thence N 01°56'30" E, 150.00 feet to the northeast corner of Lot 6, Juneau County Certified Survey Number 446;

Thence Northwesterly to the Southeast corner of parcel 4, Juneau County Certified Survey Number 445;

Thence N 01°56'30" E to the Northerly corner of parcel 4, Juneau County Certified Survey Number 445;

Thence N 21°34' E along the Westerly line of Juneau County Certified Survey Number 445 to the North line of the SE Quarter of Section 17;

Thence West along the North line of the SE Quarter of Section 17 to the Lemonweir River;

Thence Northeasterly along said river to the South line of the NE Quarter of the NE Quarter of Section 17;

Thence East along the South line of the NE Quarter of the NE Quarter of Section 17 to the Southeast corner of the NE Quarter of the NE Quarter of Section 17;

Thence North along the East line of Section 17 and Section 8 to the South right-of-way line of S.T.H. "80";

Thence East along said South right-of-way line of S.T.H. "80" to its intersection with line bearing N 66°38' E;

Thence N 66°38' E a distance of 1133.53 feet to the intersection with a line bearing S 86°29' E;

Thence S 86°29' E a distance of 819.42 feet to the Southwest right-of-way line of Interstate Highway "90 and 94";

Thence S 54°38' E to the South one-sixteenth line of Section 9;

Thence Easterly along the South line of the NW Quarter of the SE Quarter of Section 9 to the Southeast corner of the NW Quarter of the SE Quarter of Section 9;

Thence North along the East line of the NW Quarter of the SE Quarter to the Northeast corner of the NW Quarter of the SE Quarter;

Thence West along the North line of the NW Quarter of the SE Quarter to the center of Section 9;

Thence North along the East line of the SE Quarter of the NW Quarter to the Northeast corner of the SE Quarter of the NW Quarter;

Thence West along the North line of the SE Quarter of the NW Quarter to the Westerly right-of-way line of S.T.H. "80";

Thence S $83^{\circ}40'30''$ W, 1092.83 feet;

Thence S $54^{\circ}05'30''$ W 851.55 feet along the centerline of Old State Highway "80" to a line located 50 feet Northerly of and parallel to the North right-of-way line of Interstate "90 and 94";

Thence N $54^{\circ}38'$ W, 50 feet from and parallel to the North right-of-way line of Interstate "90 and 94" to the East right-of-way line of the Chicago, Milwaukee, St. Paul and Pacific Railroad;

Thence N $24^{\circ}19'$ W along said railroad right-of-way line to the North right-of-way line of Interstate "90 and 94";

Thence N $54^{\circ}38'$ W along the North right-of-way line of Interstate "90 and 94" to the East line of Section 8;

Thence North to the Point of Beginning.
