## CERTIFICATE OF INCORPORATION

OF THE

VILLAGE OF SUN PRAIRIE, DANE COUNTY

STATE OF WISCONSIN

(Under Section 61.59 of the Wisconsin Statutes)

I, FRED R. ZIMMERMAN, Secretary of State of the State of Wisconsin, do hereby certify that:

WHEREAS, The Village of Sun Prairie, Dane County, Wisconsin, a village heretofore organized under Special Law, viz: Chapter 338, Private and Local Laws of 1868 and reincorporated by Chapter 110, Private and Local Laws of 1870; and

WHEREAS, The clerk of said Village of Sun Prairie did, on the Seventh day of April, 1942, file in the office of the Secretary of State of the State of Wisconsin, a certified copy of the boundaries of said village, for the purpose of securing a village charter under the provisions of Section 61.59 of the Wisconsin Statutes; and

WHEREAS, from such certificate, it appears that the boundaries of the Village of Sun Prairie are located in Sections Four (4), Five (5), Eight (8) and Nine (9) of Township Eight (8) North of Range Eleven (11) East, in the County of Dane, State of Wisconsin, which boundaries are herein more particularly described, to-wit:

Beginning at the Southwest corner of Section Five (5), Township Eight (8) North, Range Eleven (11) East, (Town of Sun Prairie, Dane County, Wisconsin); thence North along the West line of the above mentioned Section Five (5), for a distance of three-fourths ( $\frac{3}{4}$ ) mile to the Northwest corner of the Southwest quarter of the Northwest quarter ( $SW\frac{1}{4}$  of  $NW\frac{1}{4}$ ) of said Section Five (5); thence East one and one-fourth ( $1\frac{1}{4}$ ) miles to the Northeast corner of the Southwest quarter of the Northwest quarter ( $SW\frac{1}{4}$  of  $NW\frac{1}{4}$ ) of Section Four (4), of the above mentioned township; thence South one (1) mile to the

Southeast corner of the Northwest quarter of the Northwest quarter (NW $\frac{1}{4}$  of NW $\frac{1}{4}$ ) of Section Nine (9), of the above mentioned township; thence West one and one-fourth (1 $\frac{1}{4}$ ) miles to the Southwest corner of the Northwest quarter of the Northwest quarter (NW $\frac{1}{4}$  of NW $\frac{1}{4}$ ) of Section Eight (8), of the above mentioned township; thence North one-fourth ( $\frac{1}{4}$ ) mile to the point of beginning.

Said boundaries are more briefly described as follows:

The South half (S $\frac{1}{2}$ ) and the South half of the North half (S $\frac{1}{2}$  of N $\frac{1}{2}$ ) of Section Five (5); the North half of the North half (N $\frac{1}{2}$  of N $\frac{1}{2}$ ) of Section Eight (8); the Northwest quarter of the Northwest quarter (NW $\frac{1}{4}$  of NW $\frac{1}{4}$ ) of Section Nine (9); the West half of the Southwest quarter (W $\frac{1}{2}$  of SW $\frac{1}{4}$ ) and the Southwest quarter of the Northwest quarter (SW $\frac{1}{4}$  of NW $\frac{1}{4}$ ) of Section Four (4), all in Township Eight (8) North, Range Eleven (11) East, in the County of Dane and State of Wisconsin.

NOW, THEREFORE, I, FRED R. ZIMMERMAN, Secretary of State of the State of Wisconsin, pursuant to authority vested in me by Section 61.59 of the Statutes of 1927, DO HEREBY CERTIFY that the

in the County of Dane, State of Wisconsin, having complied with the conditions precedent, is entitled to this charter, and that it is now, and has been since January 1, 1928, a duly incorporated village under General Law, as set forth in Chapter Sixty-one of the Statutes of Wisconsin and all acts amendatory thereof and supplementary thereto.

IN WITNESS WHEREOF, I have hereunto set my hand and affixed the Great Seal at the Capitol, in the City of Madison, this Seventh day of April, in the year of our Lord one thousand nine hundred and forty-two.

Dear Sir:

In response to your suggestion contained in your letter of February 7, 1942, the village board of the village of Sun Prairie, Dane County, Wisconsin, has authorized and instructed me to apply for the issuance of a certificate of incorporation to replace the special charter of the village which was repealed by Chapter 179 of the Laws of 1927. I hereby request that such certificate be issued and I certify that the following resolution was duly adopted at a regular meeting of the village board of trustees held in said village on March 2, 1942:

Whereas, the village clerk has received a communication from the office of the Secretary of State, State of Wisconsin, bearing date February 7, 1942, from which communication it appears that the special charter of the village of Sun Prairie was repealed by Chapter 179 by the Laws of 1927, and that the Secretary of State was authorized to issue to this village a certificate of incorporation under general law upon due application for the same; and it further appearing from said communication that such application was never made and such certificate of incorporation was never issued,

And whereas, the lack of such certificate of incorporation might cause legal difficulties which it is desirable to avoid,

Now therefore, be it resolved, that the village clerk be and he hereby is authorized and directed to apply for such certificate of incorporation to the Secretary of State of the State of Wisconsin, and he is hereby further authorized and directed to secure and transmit with said application a certified description of the present village boundaries, as required by section 61.59 (1) of the Wisconsin statutes.



By the order and under the direction of the Village Board of the Village of Sun Prairie, I have prepared a description of the corporate limits of the Village as they now exist, and which is as follows:

Beginning at the Southwest corner of Section 5 of Town 8 North, Range 11 East, (Township of Sun Prairie) Dane County, Wisconsin;

Thence North along the West line of the above mentioned section 5, for a distance of three - fourths mile to the Northwest corner of the Southwest one-quarter of the Northwest one-quarter;

Thence East one and one-fourth miles to the Northeast corner of the Southwest one-quarter of the Northwest one-quarter of Section 4, of the above mentioned township;

Thence South one mile to the Southeast corner of the Northwest one-quarter of the Northwest one-quarter of section 9, of the above mentioned township;

Thence West one and one-fourth miles to the Southwest corner of the Northwest one-quarter of the Northwest one-quarter of Section 8, of the above mentioned township;

Thence North one-fourth mile to the point of beginning.
