CERTIFICATE OF INCORPORATION

OF THE

CITY OF SUN PRAIRIE, DANE COUNTY, WISCONSIN (Under Section 62.06 of the Wisconsin Statutes)

I, ROBERT C. ZIMMERMAN, Secretary of State of the State of Wisconsin, do hereby certify that:

WHEREAS, the Village of Sun Prairie, Dane County, Wisconsin, was incorporated by Chapter 338, Private and Local Laws of 1868, and reincorporated by Chapter 110, Private and Local Laws of 1870, which special charter was repealed by Chapter 179, Laws of 1927, and henceforth the said village was governed by the general law relating to villages as of January 1, 1928; and

WHEREAS, the clerk of said Village of Sun Prairie did, on the Fifteenth day of May, 1958, file in the office of the Secretary of State of the State of Wisconsin, a certificate setting forth the proceedings had in and by said village, for the purpose of securing a city charter under the provisions of Section 62.06 of the Wisconsin Statutes; and

WHEREAS, from such certificate, it appears:

That the resident population of said Village of Sun Prairie exceeds One Thousand Five Hundred (1,500), as shown by the last United States census, the actual population being Two Thousand, Two Hundred Sixty-three (2,263);

That in accordance with Subsection (3) of Section 62.06 of the Wisconsin Statutes, the Village Board of Sun Prairie did, at a regular meeting held on the Seventeenth day of March, 1958, by a unanimous vote of its members adopt a resolution determining that the Village of Sun Prairie become a city of the fourth class, comprised of four wards:

That pursuant to said resolution, a special election was held on the Sixth day of May, 1958, and according to the canvass of the votes cast at said election, it appears that the total number of votes cast was Five Hundred Seventy-nine (579), of which number Two Hundred Nine-ty Five (295) votes were cast "For a City" and Two Hundred Eighty-four (284) votes were cast "Against a City"; and

That the area of the proposed City of Sun Prairie is situated in Sections Four (4), Five (5), Six (6), Eight (8) and Nine (9) of Township Eight (8) North, Range Eleven (11) East in the County of Dane and State of Wisconsin, and that the boundaries of said proposed city are more particularly described, to-wit:

Beginning at the Southwest corner of the Northwest 1 of the Northeast 2 of said Section 5; thence North 0° 33' East along the West line of said Northwest 1 of the Northeast 1 for a distance of 350.5 feet; thence North 86° 36' East 1303.0 feet; thence North 2° 59' East 526.7 feet to the North line of Benz Plat; thence North 2° 20' East 520.0 feet to the North line of said Section 5; thence North 880 11' East along said North line 1270.5 feet to the Northeast corner of said Section 5; thence North 88° 34' East along the North line of Section 4 for a distance of 1019.6 feet to the center line of U. S. ZIMMERMAN, Secretary of State of the State of Wisconsin, by virtue of authority in me vested, do hereby determine and declare that the Village of Sun Prairie, in the County of Dane and State of Wisconsin, bounded as aforesaid, has been duly incorporated as a city of the Fourth Class, according to the classification

of cities as set forth in the Wisconsin Statutes, and that from henceforth the said city shall be known as

and be governed by the provisions of Chapter 62 of the Wisconsin Statutes and laws amendatory thereof and supplementary thereto, applicable to cities of the fourth class.

I, Rudolph R. Schiller, duly elected, qualified and acting Village Clerk, of the Village of Sun Prairie, Dane County, State of Wisconsin, do hereby certify:

That, pursuant to a petition signed by more than one hundred electors and taxpayers of said Village requests the Village Board of Sun Prairie to adopt a resolution proposing that said Village be incorporated into a City of the Fourth Class, pursuant to the provisions of Section 62206 of the Wisconsin Statutes;

That in accordance with the United States Census of 1950 the population of said Village was 2,263;

That at a regular meeting of the Village Board held March 17, 1958 a resolution was adopted by a majority vote ordering a referendum election for the purpose of voting on the question of whether the Village shall incorporate into a City of the Fourth Class;

That due notice of the referendum election was published according at to law and that/said election, held on the sixth (6) day of May, 1958, the following vote was cast; 295 FOR A CITY and 284 AGAINST A CITY;

That the following area, situated in Sections 4, 5, 6, 8 and 9

Township 8 North, Range 11 East, County of Dane, comprises the corporate

limits of the proposed City of Sun Prairie:
