




CERTIFICATE OF ANNEXATION



AN ORDINANCE ANNEXING PROPERTY FROM
THE TOWN OF MIDDLETON TO THE CITY OF MIDDLETON

The Common Council of the City of Middleton do ordain as follows:

SECTION 1: Proper petition having been presented seeking annexation of the following property, to-wit:

A parcel of land located in the S 1/2 of Section 10, the N 1/2 of Section 15, and the NW 1/4 of the NW 1/4 of Section 14, T7N, R8E, Town of Middleton, Dane County, Wisconsin, more particularly described as follows:

Commencing at the southeast corner of said Section 10; thence north along the east line of said Section 10 to the south right-of-way line of USH 14 (University Avenue); thence westerly along the south right-of-way line of said USH 14 to the east line of the NE 1/4 of the SW 1/4 of said Section 10; thence southerly along the east line of said NE 1/4 of the SW 1/4 of said Section 10 to a point that is N 2 Degrees 51' W and 1,764.76 feet from the South 1/4 corner of said Section 10; thence S 87 Degrees 03' W, 924.38 feet to the centerline of Pleasant View Road; thence southerly along the centerline of said Pleasant View Road to a point 200 feet south of the northwest corner of the NE 1/4 of the NW 1/4 of said Section 15; thence easterly along a line that is parallel to and 200 feet south of the north line of said Section 15, 435.6 feet; thence northerly along a line that is parallel to and 435.6 feet east of the west line of the NE 1/4 of said Section 15, 200 feet to the north line of said Section 15; thence easterly along the north line of said Section 15, 1,050.1 feet; thence southerly along a line that is parallel to and 165 feet east of the east line of the NE 1/4 of the NW 1/4 of said Section 15, 862.3 feet; thence easterly along a line that is parallel to and 862.3 feet south of the north line of said Section 15, to the east right-of-way line of USH 12 & 14; thence northerly along the said east right-of-way line of USH 12 & 14 to a point of intersection with the north line of said Section 14; thence S 87 Degrees 45'17" W, 315.62 feet to the point of beginning.


NOW, THEREFORE, the above described property is hereby annexed to the City of Middleton.

SECTION 3: This ordinance shall take effect upon its passage and publication.






