ORDINANCE #205

AN ORDINANCE TO BE KNOWN AS CHAPTER 16, SECTION 16.15 OF THE 1969 CODE OF GENERAL ORDINANCES OF THE CITY OF MILTON, ROCK COUNTY, WISCONSIN, AMENDING TERRITORY TO THE CITY OF MILTON, ROCK COUNTY, WISCONSIN.

The Common Council of the City of Milton, Rock County, Wisconsin, do ordain as follows:

(1) Territory Annexed. In accordance with Section 66.021 of the Wisconsin Statutes and the petition for direct annexation filed with the City Clerk on the 1st day of February 1988, signed by the owner of all of the following described territory in the Town of Milton, Rock County, Wisconsin, to-wit:

Lot 1 of Certified Survey Map recorded in Volume 2 of Certified Survey Maps at Page 166, as Document No. 774819 and being a part of the NW1/4 of the NEI/4 of Section 33, Town 4 North, Range 13 East, Milton Township, Rock County, Wisconsin.

- (2) Effect of Annexation. From and after the date of this ordinance the territory described in Sub-section (1) shall be a part of the City of Milton for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Milton.
- (3) Zoning Classification. The territory annexed to the City of Milton by this ordinance is designated to be part of the B-2 district of the City of Milton for zoning purposes and subject to all provisions of "Chapter 9 Zoning Ordinances" relating to such district classifications and zoning in the City of Milton.
- (4) <u>Ward Designation</u>. The territory described in Sub-section (1) of this ordinance is hereby made a part of the 6th Ward of the City of Milton subject to the ordinances, rules and regulations of the City governing wards.
- or unconstitutional, or if the application of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or application of this ordinance which can be given effect without the invalid or unconstitutional provision or application.




