#### ORDINANCE NO. 91-415

AN ORDINANCE ANNEXING THE HEREIN DESCRIBED PROPERTY TO THE CITY OF VERONA, DANE COUNTY, WISCONSIN

The Common Council of the City of Verona, Dane County, Wisconsin, by at least a two-thirds (2/3) vote of its members, do ordain as follows:

#### Section 1. Territory Annexed.

In accordance with Section 66.021, Wisconsin Statutes, and the Petition for Direct Annexation dated January 30, 1991, with scale map attached filed with the City Zoning Administrator January 30, 1991, and there being no resident electors in the territory proposed to be annexed and said Petition being signed by the owners of all of the land in area within such territory and by the owners of all of the real property in assessed value within such territory, the following described territory in the Town of Verona, Dane County, Wisconsin, is annexed to the City of Verona, Dane County, Wisconsin.

A part of the NW1/4 of the NW1/4 of Section 15, T6N, R8E, Town of Verona, Dane County, Wisconsin, more fully described as follows:


Commencing at the Northwest corner of said Section 15; thence S89 19'13"E, 923.70 feet along the north line of the NW1/4 of Section 15 to P.O.B.; thence continue S89 19'13"E, 225.00 feet along said north line and the centerline of Cross Country Road; thence S1 27'E, 213.00 feet; thence N89 19'13"W, 225.00 feet; thence N1 27'W, 213.00 feet to P.O.B. Containing 1.10 acres and subject to existing Cross Country Road over the north 33 feet thereof. Also being Lot 1 Certified Survey Map #1994.

#### Section 2. Ward Designation.

Ward designation in Section 1 of this ordinance is hereby made a part of Ward 2 of the City of Verona, subject to the ordinance, rules and regulations of the City of Verona governing wards.

#### Section 3. Zoning District.

Pursuant to Section 10-1-24 of the City Ordinances said annexed territory is hereby zoned Multi-Family Residential (R-3) District.



## Section 4. Severability.

The provisions of this ordinance shall be deemed severable, and it is expressly declared that the Common Council would have passed the other provisions of this ordinance irrespective of whether or not one or more provisions may be declared invalid. If any provision of this ordinance or the application thereof to any persons or circumstances is held invalid, the remainder of the ordinance and the application of such provisions to other persons or circumstances shall not be affected thereby.

Section 5. Population.

The population of the annexed territory is zero (0) persons and the population of the City of Verona is estimated at 5,343.

Section 6. Effective Date.

This ordinance shall take effect upon enactment as provided in Section 66.021(7)(d), Wisconsin Statutes.
