ORDINANCE A-462

AN ORDINANCE ANNEXING TERRITORY TO THE VILLAGE OF SOMERSET, WISCONSIN

THE COMMON COUNCIL OF THE VILLAGE OF SOMERSET, WISCONSIN DO ORDAIN AS FOLLOWS:

SECTION 1. TERRITORY ANNEXED. In accordance with Section 66.021 of the Wisconsin Statutes and the petition for direct annexation filed with the Village Clerk on the 24th day of April, 2000, signed by all of the owners and electors, the following described territory in the Town of Somerset, St. Croix County, Wisconsin, is annexed to the Village of Somerset, Wisconsin:

A parcel of land located in part of the Northeast Quarter of the Northwest Quarter, Section 36, Township 31 North, Range 19 West, Lot 2 of CSM, Except the Southly 235 feet ,Town of Somerset, St. Croix County, Wisconsin.

SECTION 2. EFFECT OF ANNEXATION. From and after the date of this ordinance the territory described in Section I shall be a part of the village of Somerset for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the Village of Somerset.

SECTION 3. ZONING CLASSIFICATION. The territory annexed hereby to the Village of Somerset is zoned Single Family Residential for one year and must be reviewed by the Plan Commission for final zoning and subject to all provisions of the zoning ordinance of the village of Somerset.

SECTION 4. SEVERABILITY. If any provisions of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provisions or application.

SECTION 5. EFFECTIVE DATE. This ordinance shall take effect upon passage and publication as provided by law.
