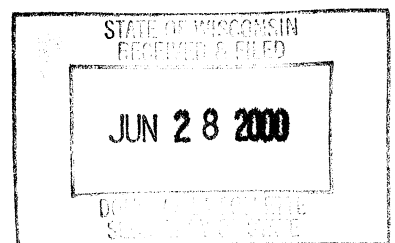
This letter is to inform you that the signature of Patricia Yagodinski, village clerk on the Ordinance A-5 for annexing territory to the Village of Casco is authentic.

AN ORDINANCE ANNEXING TERRITORY TO THE VILLAGE OF CASCO,
WISCONSIN

The Village board of the Village of Casco, Wisconsin, do ordain as follows:

SECTION 1. Direct Annexation in accordance with sec. 66.021 of the Wisconsin Statutes and the petition for direct annexation filed with the Village Clerk on the 9 day of Nov, 1999: signed by a number of electors residing in the territory equal to at least the majority of votes cast for governor in the territory at the last gubernatorial election and the owners of at least 1/2 of the land in area in the territory, the following described territory in the Town of Casco, Kewaunee County, Wisconsin, is annexed to the Village of Casco, Wisconsin.

Southeast 1/4 of the South east 1/4 of Section 7, Township 24 North, Range 24 East, Town of Casco, Kewaunee County, Wisconsin

SECTION 2. Effect of annexation. From and after the date of this ordinance the territory described in section 1 shall be a part of the Village of Casco for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the Village of Casco.

SECTION 3. The Zoning Classification. The territory annexed to the Village of Casco by this ordinance is zoned
Residential

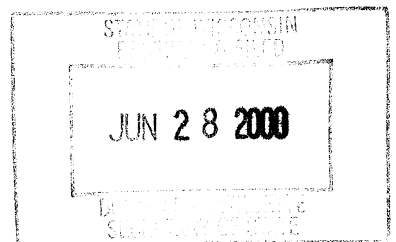
SECTION 4. Severability:. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provision or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

SECTION 5. Effective date. This ordinance shall take effect upon passage and publication as provided by law.

PURSUANT TO SEC. 66.021, WISCONSIN STATUTES

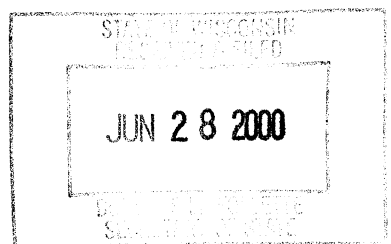

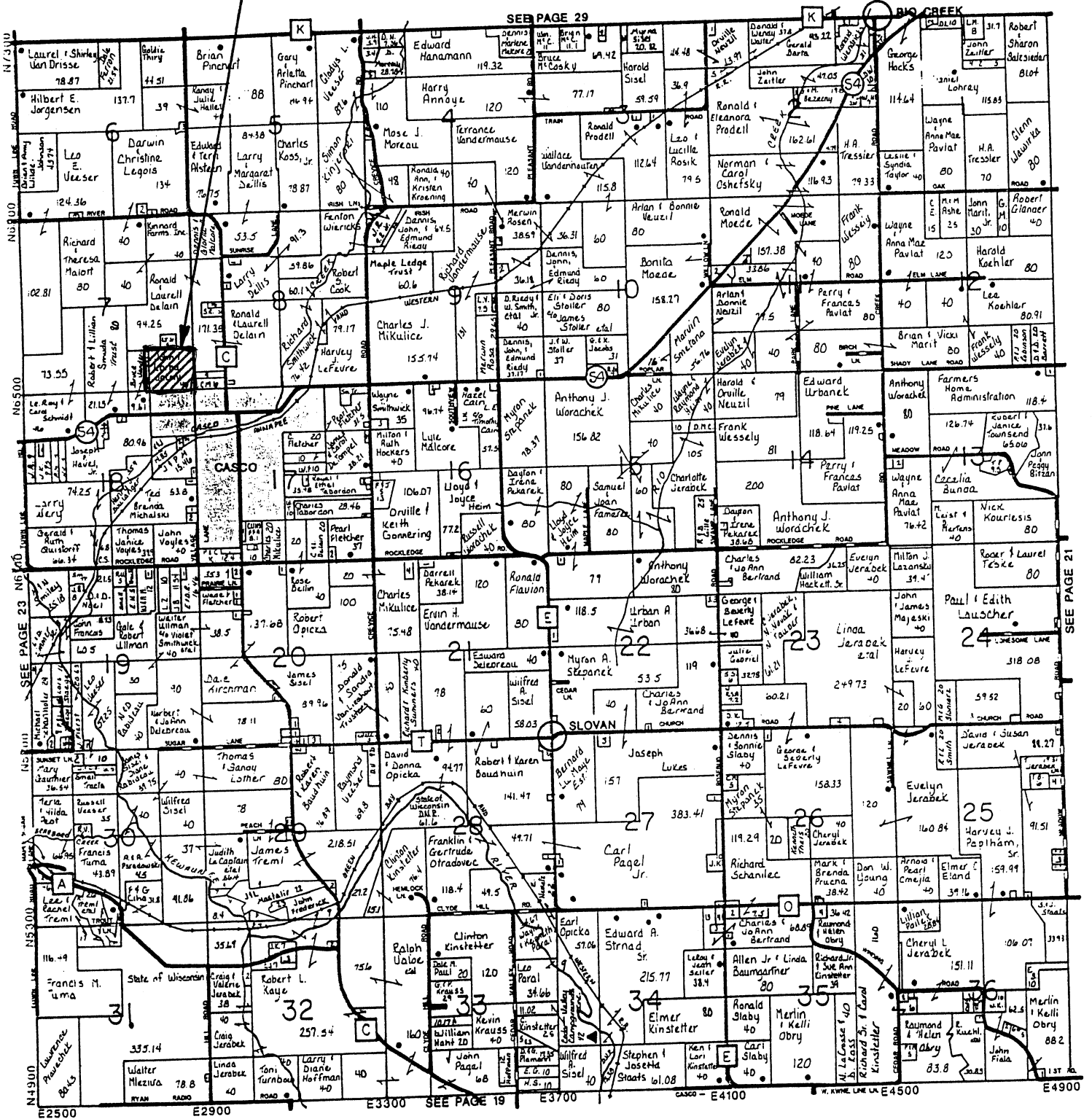
