

## VILLAGE OF CROSS PLAINS ORDINANCE NO. \0-200\



AN ORDINANCE TO REPEAL AND RECREATE VARIOUS PROVISIONS OF
CHAPTER ONE OF THE GENERAL CODE OF ORDINANCES
VILLAGE OF CROSS PLAINS, DANE COUNTY, WISCONSIN
REGARDING THE COMPOSITION AND FUNCTIONS OF THE PUBLIC FACILITIES COMMITTEE.

The Village Board of the Village of Cross Plains, Dane County, Wisconsin, hereby makes the following changes to the Village Code of Ordinances and ordains as follows:

- 1. Section 1.05(2)(C) of the Code of Ordinances pertaining to the Board of Public Works is hereby repealed and recreated to read as follows:
  - (C) <u>Public Facilities Committee</u>. The Village Public Facilities Committee shall have an odd number of voting members, consisting of at least five (5) voting members: one (1) member of the Village Board; one (1) member from the Plan Commission; and one (1) member from the Zoning Board of Appeals. The primary functions of the Public Facilities Committee shall be:
    - 1. To perform all duties customarily associated with public works projects as set forth by section 62.14(2) to (6) of the Wisconsin Statutes.
    - 2. To assume responsibility for management and administration of the water and sewer utility.
    - 3. To develop and revise as necessary a comprehensive plan for parks development.
    - 4. To develop a recreation program, including administration of the public swimming pool.

5. To establish park policy and be responsible, through staff, for administration of all parks.

All references throughout the code of ordinances to the Board of Public Works, the Parks, Playgrounds and Recreation Commission, or the Parks, Recreation and Conservancy Committee (PRC), shall be interpreted as referring to the Public Facilities Committee.

- 2. Section 1.05(2)(H) of the Code of Ordinances pertaining to the Parks, Recreation and Conservancy Committee is hereby repealed.
- 3. This ordinance shall become effective upon passage and posting pursuant to law.
