

ORDINANCE ANNEXING CERTAIN LANDS FROM THE TOWN OF GENESEE TO THE VILLAGE OF WALES, WAUKESHA COUNTY, WISCONSIN

WHEREAS, Robert M. Dugan and Barbara A. Dugan (collectively "Dugan"), have made and filed with the Village of Wales ("Village") a Petition for Direct Annexation by unanimous consent of electors and property owners of territory located in the Town of Genesee, Waukesha County, Wisconsin, to the Village of Wales, Waukesha County, Wisconsin pursuant to Wis. Stat. §66.021(12) ("Petition"), in the office of the Village Clerk for the Village of Wales, Waukesha County, Wisconsin on the 16th day of June, 2000, requesting the annexation to the Village of the land described in Exhibit "1" attached hereto and incorporated herein (hereinafter "Subject Territory") which such lands are contiguous to the Village; and

WHEREAS, it appears by carbon copy acknowledgement from Dugan that Dugan filed a duplicate original of the Petition with the Clerk of the Town of Genesee and the State of Wisconsin, Department of Administration, within five (5) days after filing the Petition with the Village Clerk; and

WHEREAS, it further appears that all the requirements of Wis. Stat. §66.021(12) have been fully complied with, and the State of Wisconsin, Department of Administration, reviewed the proposed annexation and, by letter, found it not to be against the public interest, and said letter has been duly considered and reviewed by the Village Board; and

WHEREAS, the proposed annexation was referred to the Village Planning Commission for review of and recommendation on the requested temporary zoning, and the Village Plan Commission after properly providing notice of the meeting with, a quorum present, and after full consideration given, recommended annexing the Subject Territory to the Village with Dugan's requested temporary zoning; and

WHEREAS, the Village Board of the Village of Wales after properly providing notice of this meeting, with a quorum present, and after full consideration given, makes the following findings with respect to the Subject Territory to be annexed:

A. That the annexation of the Subject Territory proposed to be annexed to the Village is in the best interest of the Village.

B. That the annexation of the Subject Territory proposed to be annexed will enable the Village to regulate and control development of these lands which are contiguous to the Village.

- C. That the annexation of the Subject Territory shall be temporarily zoned pursuant to Wis. Stat. §66.021(7), and upon review and recommendation of the Village Plan Commission, as A-1, Agricultural District.
- D. That the annexation of the Subject Territory proposed to be annexed does not create a town island under the provisions of Wis. Stats. §66.021(15).
- E. That the Village is in need of additional land suitable for residential and commercial development.

THE VILLAGE BOARD OF THE VILLAGE OF WALES, WAUKESHA COUNTY, WISCONSIN, DOES ORDAIN AS FOLLOWS:

SECTION 1: In accordance with §66.021(12), Stats., and the Petition for Direct Annexation By Unanimous Approval filed with the Village Clerk on June 16, 2000, the following described territory in the Town of Genesee, Waukesha County, Wisconsin, is annexed to the Village of Wales, to-wit:

See Exhibit "A" which is appended hereto and incorporated herein by reference.

SECTION 2: The annexed territory is hereby annexed for all municipal purposes, and all persons coming or residing within such territory shall be subject to all ordinances, rules, and regulations governing the Village.

SECTION 3: The village limits of the Village of Wales, Wisconsin are hereby changed and enlarged so as to include the real estate described in Section 1 of this ordinance, and the official map is amended to include said real estate.

SECTION 4: Those lands comprising the Subject Territory to be annexed shall be, and hereby pursuant to Wis. Stat. §66.21(7)(a) are temporarily zoned A-1, Agricultural District in accordance with the Village Zoning Ordinance, as amends.

SECTION 5: Should any section, paragraph, sentence, clause, or phrase of this ordinance be declared unconstitutional or invalid for any reason, the remainder shall not be affected thereby.

SECTION 6: All ordinances or parts of ordinances conflicting with or contravening the provisions of this ordinance are hereby repealed.

<u>SECTION 7:</u> This ordinance shall take effect upon passage and posting as provided by law.



The current population of such territory is zero (0); there are no electors residing in such territory.




