



A Charter Ordinance Modifying and Amending the General Government Code of the Municipal Code of the Village of Germantown

WHEREAS, it is deemed to be in the best interests of the Village, that the General Government Code of the Municipal Code of the Village of Germantown be modified and amended in the manner more particularly set forth.

NOW, THEREFORE, THE VILLAGE BOARD OF THE VILLAGE OF GERMANTOWN, WASHINGTON COUNTY, WISCONSIN, does ordain as follows:

SECTION I. Election Wards

The Village of Germantown is divided into three (3) Election Wards.

- 1. Election Ward Number One (1) shall be comprised of the following land to-wit:
 - A. All of Sections 1, 2, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 24, and those portions of Sections 3, 4, 5, 6, 7, 8, 9, 10, falling within the Village of Germantown.
 - B. Each Election in Election Ward Number I shall be held at the Germantown Village Hall N122 W17177 Fond du Lac Avenue.
- 2. Election Ward Number 2 shall be comprised of the following area of land to-wit:
 - A. All of sections 21, 22, 23, 25, 26, 27, 28, 29, 30 and 36.
 - B. Each election in Election Ward Number 2 shall be held at the MacArthur School W154 N11492 Fond du Lac Avenue.
- 3. Election Ward Number 3 shall be comprised of the following area of land to-wit:
 - A. All of Sections 31, 32, 33, 34, and 35.
 - B. Each election in Election Ward Number 3 shall be held at the County Line Elementary School W159 N9939 Butternut Road.

SECTION II. The procedure for the election of Village President and Trustees shall be as follows:

The term of office of each elected official shall be two years. The president shall be elected at large within the Village of Germantown in odd numbered years. Three (3) trustees shall be elected in odd numbered years, one from each ward by the electorate of that ward, and three (3) trustees shall be elected in even numbered years, one from each ward by the electorate of that ward at the regular village elections. The regular term of President and trustee shall begin on the third Tuesday of April in the year of their election.

SECTION III. Except as hereinabove specifically modified and amended, the Municipal Code of the Village of Germantown shall remain in full force and effect as originally adopted and previously amended.

SECTION IV. The first election of trustees by wards under this ordinance shall be held in 1973. The incumbant trustees whose position is not scheduled for election in 1973 shall not stand for election in 1973. All other trustee positions created by this ordinance shall be elected in 1973. If there is no incumbant trustee residing in a ward, the two individuals receiving the highest vote from the ward shall be the trustees, with the individual receiving the highest vote receiving the two year term and the individual receiving the second highest vote the one year term. If there is an incumbant trustee in the ward, an election for one trustee for a two year term shall be held.

SECTION V. This Ordinance shall be in full force and effect sixty (60) days after its passage and publication.

SECTION VI. All ordinances or parts of ordinances inconsistant with or in contravention of this ordinance are hereby repealed.
