### CORRECTED ORDINANCE #2001-05

# ANNEXING TERRITORY AND ASSIGNING A TEMPORARY ZONING CLASSIFICATION

The Common Council of the City of Ladysmith do ordain as follows.

1. That the City of Ladysmith does hereby annex from the Town of Flambeau the following described property.

#### Lot 3 in Block 6 of Ladysmith Townsite Company's Third Addition.

- 2. That the property described in 1., above, is hereby temporarily zone R-1, Single Family Residential, until such time as a permanent zoning district classification is assigned and that this temporary classification shall be recorded on the City of Ladysmith Zoning District Map.
- 3. That the property described in 1., above, is hereby attached as Ward 19 as provided for by Wisconsin Statutes.
- 4. That this ordinance shall take effect upon passage and publication.
