



AN ORDINANCE ANNEXING CERTAIN LANDS OF THE TOWN OF WAUKESHA TO THE CITY OF WAUKESHA, WISCONSIN

THE COMMON COUNCIL OF THE CITY OF WAUKESHA DO ORDAIN AS FOLLOWS:

SECTION I. In accordance with Section 66.021 of the Wisconsin Statutes and petition for annexation filed with the City Clerk on the 4th day of March, 2002, the following described territory in the Town of Waukesha, Waukesha County, Wisconsin is annexed to the City of Waukesha:

Being a part of the NE ¼ of Section 6 and NW ¼ of Section 5, T6N, R19E Town of Waukesha, Waukesha County, Wisconsin, more fully described as follows:

Beginning at the NW corner of said Section 5; thence N 88°29'26" E., along the North line of the NW 1/4 of said Section 5, 903.00 feet to a point; thence S 00°03'01" W., 131.00 feet to a point; thence S 88°29'26" W., 903.00 feet to a point on the West line of said Section 5; thence S 00°03'01" W., along said West line, 1436.08 feet to a point on the centerline of C.T.H. "TT"; thence S 02°08'20" W., along said centerline, 296.05 feet to a point; thence 398.28 feet, continuing along said centerline and the arc of a curve to the right, with a radius of 1333.00 feet, whose chord bears S 13°15'26" W., 396.80 feet to a point; thence S 21°49'01" W., continuing along said centerline, 320.07 feet to a point on the South line of the NE 1/4 of said Section 6; thence S 87°24'20" W., along said South line, 1060.70 feet to a point; thence N 00°09'06" W., 1298.68 feet to the northerly right-of-way of Madison Street; thence N 80°04'37" W., along said northerly right-of-way line 197.71 feet to a point; thence N 00°03'01" E., 1231.09 feet to a point on the North line of the NE $\frac{1}{4}$ of said Section 6, thence N 88°49'13" E., along said North line, 1479.39 feet to the point of beginning. Said lands containing 3,570,487 square feet (81.97 acres).


SECTION II. The above shall be zoned pursuant to the authority granted in Section 66.021(7) of the Wisconsin Statutes as T-1, Temporary Zoning District except the following which shall be zoned C-1, Conservancy District:

SECTION III. The annexed territory is hereby made a part of the Thirteenth Aldermanic District, and is in the Forty-seventh Ward of the City of Waukesha and is annexed for all municipal purposes including annexation for school purposes and is hereby made a part of the School District of Waukesha, and subject to laws governing the same.

SECTION IV. The City limits of the City of Waukesha, Wisconsin are hereby changed and enlarged as so to include the real estate described in Section I of this ordinance and the official map is amended to include said real estate.

SECTION V. Should any section, paragraph, sentence, clause or phrase of this ordinance be declared unconstitutional or invalid for any reason, the remainder shall not be affected thereby.

SECTION VI. All ordinances or parts of ordinances inconsistent with or contravening the provisions of this ordinance are hereby repealed.

SECTION VII. This ordinance shall be in full force and effect from and after its passage and publication by law.


