



# RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF WHITEWATER CORRECTING THE LEGAL DESCRIPTION IN THE PAMELA T. KRAUS, RICHARD W. KRAUS, JR. & WISCONSIN DEPARTMENT OF TRANSPORTATION ANNEXATION

WHEREAS, a Petition for Direct Annexation was filed regarding properties owned by Pamela T. Kraus, Richard W. Kraus, Jr. and the Wisconsin Department of Transportation on September 12, 2001, and

WHEREAS, the Common Council for the City of Whitewater did grant said petition for annexation on November 6, 2001. A copy of the Certificate for Annexation is attached hereto and labeled Exhibit A, and

WHEREAS, while conducting further surveying and engineering work in the area of the annexation, subsequent to the adoption of the annexation ordinance, the City of Whitewater Engineering Division discovered a scrivener's error in the property description which was set forth in the petition, and

WHEREAS, said error was a minor error regarding the legal description set forth in the Petition, and

WHEREAS, it is necessary to correct the legal description and the map to properly reflect the intent of the parties and the intent of the annexations, and

WHEREAS, the Director of Municipal Boundary Review at the State of Wisconsin Department of Administration has advised the City of Whitewater to correct the legal description and map by resolution.

NOW THEREFORE, the Common Council of the City of Whitewater determines that the legal description in the Pamela T. Kraus, Richard W. Kraus, Jr. and Wisconsin Department of Transportation annexation which took place by Ordinance No. 1493 on November 6, 2001 shall be corrected to conform to the intent of the petitions and resolve that the legal descriptions in said annexation and the map shall be corrected as follows:

The legal description shall be corrected to be as set forth in the attached Exhibit B, attached hereto, which is an annexation legal description revised by James K. Langone on February 6, 2002, and the map shall be corrected as set forth in Exhibit C attached hereto.

THENCE S 88°09'39" W, ALONG THE EW 1/4 LINE, 619.44 FEET MORE OR LESS, TO THE CENTERLINE OF STATE HIGHWAY "59":

THENCE S 44°15'34" W, ALONG SAID CENTERLINE, 175.83 FEET MORE OR LESS, TO THE SW CORNER OF THAT CERTAIN PARCEL OF LAND DESCRIBED IN A DEED RECORDED IN VOL. 347, PAGE 363, RECORDS OF WALWORTH COUNTY;



### ORDINANCE NO. 1493

## ORDINANCE ANNEXING TERRITORY TO THE CITY OF WHITEWATER, WISCONSIN

The Common Council of the City of Whitewater, Wisconsin, does ordain as follows:

SECTION 1. Territory Annexed. In accordance with sec. 66.0217 of the Wisconsin Statutes in the petition for direct annexation filed with the City Clerk on the <a href="https://linear.com/

That portion of the SE ¼, and SW ¼, Section 8, T4N, R15E, in the Town of Whitewater, Walworth County, Wisconsin, described as follows:

"Beginning" at the E. ¼ corner, Sec. 8, T4N, R15E; thence S 88°10'17" W, along the EW ¼ line, 2639.09 feet, to the ctr. ¼ corner said Sec. 8; thence S 89°09'39" W. along the EW ¼ line, 608.55 feet more or less, to the centerline of State Highway "59";

thence S 44°15'34" W, along said centerline, 191.13 feet more or less, to the SW corner of that certain parcel of land described in a deed recorded in Vol. 347, page 363, Records of Walworth County;

thence S 79°21'54" E, along the S. line of said parcel, 611.79 feet, to an angle point therein;

thence continuing along said S. line, S 59°08'33" E, 272.80 feet, to a point on the NS ¼ line said Sec. 8, said point being 380.19 feet S'ly of the ctr. ¼ corner said Sec. 8;


thence continuing S 59°08'33" E, 920.81 feet more or less, to a point on the W. line of State Highway "89";

thence N 0°01'19" W, 357.09 feet more or less, to the NW corner of that certain parcel described in a deed recorded in Vol. 670, page 1339, Records of Walworth County, said corner being described as on the centerline of State Highway "89";

thence S 81°49'00" E, along the N. line of said parcel, 550.68 feet more or less, to the NW corner of Certified Survey Map No. 489, recorded in Vol. 2, page 311 of Certified Surveys of Walworth County;

thence N 68°59'00" E, along the N'ly line of said CSM, 86.68 feet, to an angle point therein;

thence continuing along said N'ly line, S 88°52'00" E, 355.06 feet, to the NE comer thereof;

thence S 0°16'43" W, along the E. line of said CSM, 504.12 feet to a point, said point being 147.88 feet N. of the SE corner of said CSM, said SE corner being on the centerline of a town road;

thence S 86°06'06" E (recorded as parallel to the centerline of said town road), 856.31 feet, to a point on the E. line of said Section 8, said point being 110.59 feet N'ly of the SE corner of the NE ¼, NE ¼, said Section 8;

thence N 0°56'05" E, along the E. line of said Section 8, 1208.78 feet, to the "point of beginning".

Being 51.2 acres more or less.

ABSENT: None

SECTION 2. Effect of Annexation. From and after the date of this ordinance the territory described in Section 1 shall be a part of the City of Whitewater for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Whitewater.

SECTION 3. Temporary Zoning Classification. Pursuant to City of Whitewater Ordinance 19.12.040 this territory annexed to the City of Whitewater is Zoned AT, Agricultural Transition District. Within one year of the date of this ordinance, the City Plan Commission shall evaluate and recommend a permanent classification to the Common Council.

SECTION 4. Ward Designation. The territory described in Section 1 of this ordinance is hereby designated Ward 12 of the City of Whitewater, subject to the ordinances, rules and regulations of the City of Whitewater governing wards.

SECTION 5. Severability. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

SECTION 6. Effective date. This ordinance shall take effect upon passage and publication as provided by law.


