





#### ORDINANCE NO. 991

### AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF HARTFORD, WISCONSIN (16.5678 Acres – Spaeth & Wald)



The Common Council of the City of Hartford, Washington/Dodge Counties, Wisconsin, do ordain as follows:

**SECTION 1: TERRITORY ANNEXED.** In accordance with Section 66.0217 of Wisconsin Statutes, the following described territory located in the Town of Hartford, Washington County, Wisconsin is annexed to the City of Hartford, Wisconsin:

Being a part of the Northwest 1/4 of the Northwest 1/4 of Section 17, Township 10 North, Range 18 East, Town of Hartford, Washington County, State of Wisconsin, more fully described as follows:

Commencing at the Northwest corner of said Northwest 1/4, said corner also being the place of beginning of the lands to be described; Thence S 00° 17' 35" E, along the West line of said Northwest 1/4, 658.75 feet; Thence N 89° 50' 40" E, 1322.03 feet to the East line of the West half of said Northwest 1/4 and the centerline of Airport Drive (C.T.H. "U"); Thence N 00° 12' 32" W, along said East line, 74.85 feet to a point on the centerline of Airport Drive (C.T.H. "U"); Thence S 89° 47' 20" W, 256.00 feet to a point; Thence N 00° 12' 32" W, 584.15 feet to the North line of said Northwest 1/4; Thence S 89° 50' 40" W, along said North line, 1067.00 feet to the place of beginning. Said lands containing 16.5678 gross acres.

**SECTION 2: EFFECT OF ANNEXATION.** From and after the date and filing of this ordinance, the territory described in Section 1 shall be a part of the City of Hartford for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Hartford.

**SECTION 3: ZONING CLASSIFICATION.** The parcel of land shall be zoned Rs-4 Single-Family Residential, with the exception that one lot at the southeast corner described as:

Being a part of the Northwest 1/4 of the Northwest 1/4 of Section 17, Township 10 North, Range 18 East, Town of Hartford, Washington County, Wisconsin, more particularly described as follows:

Commencing at the Northwest corner of said Northwest 1/4; Thence N 89° 50' 40" E., along the North line of said Northwest 1/4, 1067.00 feet; Thence S 00° 12' 32" E., 584.15 feet to the place of beginning of the lands to be described; Thence N 89° 47' 20" E, 256.00 feet to the centerline of Airport Drive (C.T.H. "U") and the East line of the West 1/2 of said Northwest 1/4; Thence S 00° 12' 32" E, along said centerline, 74.85 feet; Thence S 89° 50' 40" W, 256.07 feet; Thence N 00° 09' 20" W, 74.60 feet to the place of beginning. Said lands containing 0.44 acres.

SECTION 4: ALDERMANIC DISTRICT DESIGNATION. The territory described in Section 1 of this Ordinance is hereby made part of the 1st Aldermanic District of the City of Hartford, subject to the rules, ordinances, and regulations of the City governing aldermanic districts.

**SECTION 5:** WARD DESIGNATION. Ward 24 is hereby created to encompass the territory described in Section 1 of this Ordinance.

SUPERVISORY DISTRICT DESIGNATION. The territory described **SECTION 6:** in Section 1 of this Ordinance is hereby made part of the 9th Supervisory District.

**SECTION 7:** OFFICIAL MAP. The City of Hartford Official Map is hereby amended to include the territory described in Section 1 as a contiguous part of the City of Hartford.

**SECTION 8:** EFFECTIVE DATE. This Ordinance shall take effect upon passage and publication as required by law.
