

## CITY OF PORT WASHINGTON OZAUKEE COUNTY, WISCONSIN ORDINANCE NO. 2003 - 15

# AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF PORT WASHINGTON, WISCONSIN

The Common Council of the City of Port Washington, Wisconsin, do ordain as follows:

SECTION 1. Territory Annexed. In accordance with sec. 66.0217 of the Wisconsin Statutes and the Petition for Direct Annexation filed with the City Clerk at 1:10 p.m. on the 9th day of July, 2003, signed by all of the owners of the real property, in which no electors reside, in the territory to be annexed as of the date of filing of the Petition, the following described territory in the Town of Port Washington, Ozaukee County, Wisconsin, is annexed to the City of Port Washington, Wisconsin:


- **SECTION 2. Effect of Annexation.** From and after the date of this ordinance the territory described in Section 1 shall be a part of the City of Port Washington for any and all purposes provided by law, and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Port Washington.
- **SECTION 3. Temporary Zoning Classification.** (a) Upon recommendation of the Plan Commission, the territory annexed to the City of Port Washington by this ordinance is temporarily zoned as follows, pursuant to sec. 66.0217(8) of the Wisconsin Statutes: AG Agricultural District
- (b) As soon as practicable following annexation of the territory described in Section 1, the Plan Commission shall prepare an amendment to the zoning ordinance setting forth permanent classifications and regulations for the zoning of the annexed area and submit its recommendations to the Common Council.
- **SECTION 4. Ward Designation.** The territory described in Section 1 of this ordinance is hereby made a part of the <u>3rd</u> ward of the City of Port Washington, subject to the ordinances, rules and regulations of the City of Port Washington governing wards.
- **SECTION 5.** Severability. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

Adams Subdivision of Gov't Lots 3 and 4, Section 33 which is the Point of Beginning; thence S 87°30'05" W. 1017.28' along the North line of the South 63.00' of Lot 3, B.F. Adams Subdivision of Gov't Lots 3 and 4, Section 33 to the Easterly right-of-way line of County Highway "C"; thence N 17°11'40" E. 392.97' along the Easterly County Highway right-of-way line; thence N 17°32'39" E. 947.90' along the Easterly County Highway right-of-way line; thence N 17°46'37" E. 669.88' along the Easterly County Highway right-of-way line; thence N 17°46'37" E. 689.60' along the Easterly County right-of-way line; thence N 87°50'18" E. 192.36'; thence N 17°27'35" E. 56.05' to the North 1/16th line of Section 33 being the Southerly City limits of Port Washington; thence N 87°27'40" E. 891.30' to a traverse line along the Westerly shore of Lake Michigan; thence S 19°39'19" W. 754.77' along the traverse line; thence S 19°19'40" W. 1615.57' along the traverse line; thence S 15°47'31" W. 409.80' along the traverse line to the Point of Beginning containing 61.52 acres and subject to restrictions, reservations, rights-of-way and easements of record. The Easterly Boundary of this parcel extends to the ordinary high watermark of Lake Michigan.


